Subject: Public Hearing – Boone County Roadway Regulations Chapter I: **Vehicular Traffic Regulations**

Commissioner Schnarre opened the floor for a public hearing on this item.

Commissioner Schnarre closed the public hearing.

Subject: Information Technology

Michael Mallicoat, Information Technology Director, was present on behalf of these items.

A. Second Reading and Approval of Request for Administrative Authority to Purchase Laptop Computers, Personal Computers, Peripherals and Printers from Cooperative Contracts for FY04

Commissioner Elkin moved to approve the request from the Information Technology Department for Administrative Authority to purchase laptop computers, personal computers, peripherals and printers from cooperative contracts for fiscal year 2004.

Commissioner Miller seconded the motion.

There was no discussion and no public comment.

The motion passed 3-0. Order 556-2003

B. First Reading of Budget Revisions

Michael Mallicoat stated there are three budget revisions. The first is to transfer funds between accounts to pay for postage for mailing the declarations for the Assessor's Office. This budget revision is for \$20,000 and will be reimbursed from the Assessor's Office.

The second budget revision is to transfer funds between accounts for Mail Services for minor year-end adjustments. This budget revision is for \$1,235.

The final budget revision is for Information Technology to transfer funds between accounts for the Microsoft Software Assurance. This budget revision is for \$11,000. This licensing agreement will cover three years instead of two as he originally thought. The total license agreement is for approximately \$68,000.

There was no further discussion on these items.

Commissioner Schnarre stated this is a first reading and requested the Deputy County Clerk to schedule these items for a second reading at the next available meeting with an appropriate order for approval.

Subject: County Commission

A. Second Reading and Establishment of Construction Budget for JJC Expansion and City/County Health Facility and Approval of Funding Source

Commissioner Schnarre moved revise the existing Fiscal Year 2003 appropriations for the Juvenile Justice Center Addition Project and the City/County Health Facility Project as outlined in the schedule. In addition, the Boone County Commission does hereby approve the allocation of Series 2003 Capital Improvement Bond Proceeds as outlined in the schedule.

Commissioner Elkin seconded the motion.

There was no discussion and no public comment.

The motion passed 3-0. Order 557-2003

B. Second Reading to Authorize Presiding Commissioner to sign Change Orders up to \$25,000 for the Health Facility Project

Commissioner Miller stated she is not comfortable with the \$25,000 limit. She requested the Change Orders be brought forward at a Commission meeting, at least given as a Commission Report so the public is aware of what is happening.

Commissioner Schnarre agreed and will bring any change order that he has signed to be part of the public record.

Commissioner Miller moved to authorize the Presiding Commissioner to sign individual change orders in amount equal or less than \$25,000 for the City/County Health Facility Project.

Commissioner Elkin seconded the motion.

There was no discussion and no public comment.

The motion passed 3-0. Order 558-2003

Subject: Second Reading and Approval of Ordinance to Opt Out of State Imposed Sales Tax Holiday

Commissioner Schnarre stated the City of Columbia opted out last night at their meeting with a 5-2 vote. Callaway County and Cole County have opted out of the State imposed sales tax holiday.

Commissioner Miller moved to adopt the following ordinance:

Whereas, the Missouri General Assembly has passed and the Governor has signed, Senate Bill 11 that establishes a so-called "sales tax holiday" for the second weekend in August, 2004, and

Whereas, the legislation does not provide for the reimbursement to local governments for lost revenues, and

Whereas, the sales tax holiday will significantly reduce local revenues, and

Whereas, counties depend on sales tax revenues to provide essential services for the citizens, including law enforcement, property assessment, roads, tax collection, etc., and,

Whereas, these sales taxes were approved by a vote of the people who expect the

promised services, and

Whereas, the legislation authorizes local governments to opt out of the sales tax holiday by ordinance of the governing body,

Now therefore be it ordained by the County Commission of the County of Boone as follows:

Section One. The County of Boone hereby determines that it will prohibit the provisions of Section 144.049 RSMo., 2003, from exempting sales of certain clothing, personal computers, certain computer software, and school supplies that occur within the boundaries of said County during August 13, 2004 through August 15, 2004 from local taxes.

Section Two. The County Clerk is hereby directed to send written notice to the State of Missouri Department of Revenue as soon as possible, but no later than July 9, 2004, of the decision to opt out of the "Sales Tax Holiday," by forwarding a cover letter and certified copy of this ordinance.

Section Three. This ordinance shall be in full force and effect from and after the date of its passage and approval.

Commissioner Elkin seconded the motion.

Commissioner Miller stated she sent an e-mail to all first class counties and has received notification that the majority are opting out also. Camden County is the only county not opting out. Platte County will make their decision after January 1, 2004.

Commissioner Miller stated this is an unfunded mandate by the legislature if the county does not opt out. The citizens of Boone County voted for these taxes for specific projects. She believes Boone County should wait to see how this will affect the State.

She stated the state of Florida had something similar to this and they repealed it because it was not successful.

Commissioner Schnarre stated the state of Texas has a similar law and they do not have a problem with it.

Commissioner Miller stated this is a national movement by the May Company. She spoke with one of their lobbyist this weekend.

Commissioner Schnarre stated the Commission received a letter from the Chamber of Commerce noting their decision to be neutral on this issue. The Columbia Mall also sent a letter supporting the County's decision to opt out. Glenda Castrop, 9150 Owens School Road, Hallsville, stated she is opposed to the Commission's decision to opt out. She believes that this would greatly help people who make minimum wage. She believes the governments should work together.

Commissioner Elkin stated he agrees with Hank Waters' editorial in the December 15, 2003 Tribune and believes there should be something to the effect of a tax holiday or credit based on income, not just an across the board tax holiday. He understands the people who have lower incomes should have a break but does not believe this is the way to do it. He agrees with Commissioner Miller that Boone County should wait to see how this will affect the State.

He noted there will still be a reduction in the taxes on those dates because there will be no state sales tax.

He suggested MAC taking the lead in doing a means tested way of doing this instead of the blanket tax holiday.

There was no further discussion or public comment.

The motion passed 3-0. Order 559-2003

Subject: Second Reading and Approval of Request for Approval of Fireworks Display on County Property (First Night Columbia)

Commissioner Schnarre moved to approve the request from First Night Columbia 2004 to conduct a fireworks display from the Courthouse Square on New Year's Eve 2003.
