Planning and Building

Bill Florea, Planning and Building, was present on behalf of this item.

1. Budget Amendment to Establish Hinkson Budget (first reading)

Mr. Florea stated this is to establish funding for the remainder of 2008 for the Hinkson grant program that was just approved two weeks ago. He stated all of the cash outlay will be 100% reimbursed by the Department of Natural Resources (DNR). All the County has to do is provide a 40% match. He stated we are planning on doing that with in-kind and some cash contributions. He stated we have developed a pretty significant partnership list. The value of some of their contributions has yet to be established. One of the activities is to sponsor a public service announcement (PSA) contest where local film makers will do short PSAs on storm water issues. Columbia Access Television has committed to providing studio space and other contributions. There is a total of \$325,712 in commitments for the match; the required match is \$200,599, so there is a surplus of about \$125,000.

Commissioner Miller asked how many applicants we have gotten for this position.

Mr. Florea stated we have received one.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.
