Reintegration Court

Casey Forbis, Reintegration Court, was present on behalf of this item.

1. Recovery Act: Edward Byrne Memorial Competitive Grant Application

Ms. Forbis stated this is the federal version of the grant she applied for in February. She stated the application is for participant employment in employment training, substance abuse treatment, and funding for personnel. She stated there is no match required. Funding would begin July 31 and last for 24 months.

Commissioner Miller asked if this requires that the people you hire or the programs that you start must be continued after the grant ends.

Ms. Forbis stated there is no such requirement.

Commissioner Miller asked if she will be telling the people she hires that it is a two year grant.

Ms. Forbis stated the funding for the personnel is for her position.

Commissioner Elkin moved on this day the County Commission of the County of Boone does hereby authorize the Presiding Commissioner to sign the Edward Byrne Memorial Competitive Grant Application for the Reintegration Court.

Purchasing

Tyson Boldan, Purchasing, was present on behalf of these items.

2. 11-19MAR09 – Old Highway 124 Asphalt Overlay & Roadway Drainage Improvements (first read on 3/19/09)

Mr. Boldan stated the bid for Old Highway 124 Asphalt Overlay & Roadway Drainage Improvements closed on February 19, 2009. Four bids were received. Purchasing and the Public Works Department recommend award to APAC Missouri Inc. for offering the lowest and best bid for Boone County.

Bid total of contract is \$447,417.63 with a 10% contingency amount of \$44,741.76 for a Purchase Order total of \$492,159.39. Contract will be paid from Department 2040 – PW – Maintenance Operations, Account 71100 – Outside Services. The budgeted amount was \$598,777.00.

Commissioner Miller moved on this day the County Commission of the County of Boone does hereby award bid 11-19MAR09 – Old Highway 124 Asphalt Overlay & Roadway Drainage Improvements to APAC Missouri Inc. It is further ordered the Presiding Commissioner is hereby authorized to sign said contract.

Commissioner Elkin seconded the motion.

3. 14-26MAR09 – Oakland Church Road Asphalt Overlay & Drainage Improvements (first read on 3/26/09)

Mr. Boldan stated the bid for Oakland Church Road Asphalt Overlay & Drainage Improvements closed on March 26, 2009. Three bids were received. Purchasing and the Public Works Department recommend award to Christensen Construction for offering the lowest and best bid for Boone County.

A deduction of \$1,990 for Recycle Asphalt Products brings the bid total to \$196,120.00 with a 10% contingency amount of \$19,612.00 for a Purchase Order total of \$215,732.00. Contract will be paid from Department 2040 – PW – Maintenance Operations, Account 71100 – Outside Services. The budgeted amount was \$75,680.

Commissioner Miller stated we changed the scope of the project so we won't have to mess with this again for at least ten years.

Commissioner Elkin stated we went from a micro surface or chip and seal to overlay, which buys a lot more time.

Commissioner Miller stated she thinks it is a good move.

Commissioner Elkin moved on this day the County Commission of the County of Boone does hereby award bid 14-26MAR09 – Oakland Church Road Asphalt Overlay & Drainage Improvements to Christensen Construction. It is further ordered the Presiding Commissioner is hereby authorized to sign said contract.

7. Commissioner Reports

Commissioner Miller reported on the following:

Missouri Association of Counties: Commissioner Miller stated she and Commissioner Pearson attended the Missouri Association of Counties legislative conference and it was pretty discouraging from her perspective.

Commissioner Pearson stated he thought the Governor's speech was pretty good. He stated it is too bad he is not getting more support in the legislature for what he is trying to do. He stated he was disappointed in the Voter ID bill proposed by Representative Deeken and his rationale for it.

Commissioner Miller stated she is concerned that they will pass it and say that they will pay for it and then not appropriate for it.

Commissioner Pearson stated his approach and his logic were pretty weak. He stated they coupled it with the early voting.

Commissioner Miller stated we also had Representatives President Pro Tem Shields and House Speaker Richards.

Commissioner Elkin asked what they had to say.

Commissioner Miller stated the Senate is in a log jam with those five senators that are holding up everything over tax credits. She stated last night the House stripped the \$100 million out of the economic bill stalled in the Senate and put it to different projects. She stated they don't think they will get a budget passed and will have to come back for special session.

Commissioner Elkin stated from what he knows Senator Shields and Representative Richards are pretty moderate, reasonable people, but they have a faction of really hard-liners that tie everything up.

Commissioner Pearson stated Senator Griesheimer was pretty angry with the Farm Bureau. He
