The meeting was called to order at 1:30 p.m.

Sheriff's Department

1. Budget amendment for MO ICAC grant (first reading)

Boone County Sheriff Dwayne Carrey was present on behalf of this item. Sheriff Carey stated this is for the Internet Crimes Task Force. Sheriff Carey stated they occasionally hand money down to the regional partners. Sheriff Carey stated that's what this is, \$10,000 for training, equipment, and travel.

Commissioner Miller stated it appears every other day in the paper that Andy has someone in court for child porn.

Sheriff Carey stated he is number one in the state of Missouri.

Commissioner Atwill stated he's nailing them all over the country isn't he?

Sheriff Carey stated yes.

Commissioner Atwill stated that's amazing.

Sheriff Carey stated yes, but unfortunate.

Commissioner Miller stated it's sad and sickening.

Commissioner Atwill stated it's incredibly well done.

Sheriff Carey stated initially they were hoping to get a lot of cooperation from other departments, and have six agencies involved in this. Sheriff Carey stated it never panned out after the economy went south.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading after the 10 day hold required for budget amendments with an appropriate order for approval.

2. Accept of 2012-13 STOP VAWA grant award (first and second reading)

Domestic Violence Coordinator Jeremy Cover was present on behalf of this item. Mr. Cover stated VAWA stands for Violence Against Women Grant. Mr. Cover stated it is a grant the County has received for four years now. Mr. Cover stated this year it switched to a two year grant. Mr. Cover stated that's why we're accepting it for both 2012 and 2013. Mr. Cover stated there is a 25% County match, but this grant funds the Batterers' Intervention program, as well as his salary. Mr. Cover stated the 25% match is provided by what the participants pay.

Commissioner Miller asked Mr. Cover if he would be submitting a budget amendment.

Mr. Cover stated they will be doing a budget amendment after this is approved.

Commissioner Miller moved on this day the County Commission of the County of Boone does hereby accept the STOP Violence Against Women grant award from the Missouri Department of Public Safety for the 13th Judicial Circuit Court in the amount of \$114,261.41.

Commissioner Atwill seconded the motion.

3. Agreement for Batterer's Intervention Program (first and second reading)

Domestic Violence Coordinator Jeremy Cover was present on behalf of this item. Mr. Cover stated this is the agreement with Family Counseling Center, which actually provides the Batterers' Intervention Program. Mr. Cover stated the agreement is they will provide the services within the frames the County sets aside. Mr. Cover stated it is a

two year contract because the grant is a two year grant. Mr. Cover stated the contract states Family Counseling Center will provide the class, how many classes a week they do, and that they will do the billing.

Commissioner Miller asked why this is a first and second reading.

Mr. Cover stated he received the grant paperwork on the 8^{th} , and it's due back on the 22^{nd} .

Commissioner Miller stated she thinks in the future you need to be cognizant that the Commission likes to do first and second readings on different days. Commissioner Miller stated as soon as you get it, have it put on the agenda, and we'll work through it.

Commissioner Miller moved on this day the County Commission of the County of Boone does hereby approve the contract between Family Counseling Center of Missouri, Inc. and Boone County, Missouri for a batterers' intervention program. The terms of this agreement are stipulated in the attached contract. It is further ordered the Presiding Commissioner is hereby authorized to sign said contract.

4. Cooperative Contract: AEPA009.D – Copier and Maintenance for Prosecuting Attorney (first reading)

Director of Purchasing Melinda Bobbitt was present on behalf of this item. Ms. Bobbitt read the following memo:

Purchasing and the Prosecuting Attorney's office request permission to utilize the Association of Educational Purchasing Agencies (AEPA) cooperative contract AEPA009.D with da-com of Columbia, Missouri to purchase a copier and maintenance.

Total cost of copier is \$9,082 and will be paid from department 1261 – Prosecuting Attorney, account 92300 – Replacement Machinery & Equipment. \$10,500 was budgeted for this purchase.

Copier maintenance pricing is firm for a total of seven years for \$0.0089/black & white copy. Maintenance will be billed in arrears, quarterly.

Purchasing is seeking permission to dispose of the existing Kyocera KM4030 copier, fixed asset tag 14071 by trade-in with a zero value. Da-com has agreed to remove the hard drive (if one exists) to leave with County and will haul off the existing machine to

recycle. Past experience has taught us it costs us more to move the copier to surplus then to sell it on GovDeals. Attached for signature is the Request for Disposal form.
