Presiding Commissioner Daniel K. Atwill was absent.

The meeting was called to order at 9:30 a.m.

#### **Treasurer**

#### 1. Updates to the P-Card Policy and Administrative Procedures (first reading)

Boone County Treasurer Nicole Galloway was present on behalf of this item. Ms. Galloway stated the P-Card program was implemented in 2006, and since that time the administrative procedures had not been reviewed to reflect current practices. Ms. Galloway stated the policy has been updated to reflect what happens in practice. Ms. Galloway stated if someone wants to be part of the program, they will be able to refer to the policy more thoroughly. Ms. Galloway stated her office also looked at two years worth of transactions to determine if there were any consistent problems with the program, and found there were no consistent patterns of problems with any office or users. Ms. Galloway stated this really speaks to the controls the P Card program has. Ms. Galloway stated one of the things we also did was sent every elected official and department head an inventory of their P Card holders, along with their limits and transactions. Ms. Galloway stated it allowed them to review the transaction limit and credit limit they set for their cardholders, and there were some adjustments made. Ms. Galloway stated this will now take place annually. Ms. Galloway stated she would go over a summary of changes. Ms. Galloway stated Senate Bill 729 has changed the bid threshold. Ms. Galloway stated previously you could make purchases up to \$2,500, and then you would need to get three quotes to get your limit raised. Ms. Galloway stated now we're getting rid of all the quotes, but keeping the maximum allowable limit at \$2,500. Ms. Galloway stated the intent of the program is to pay for small dollar transactions and add flexibility. Ms. Galloway stated over the last two years, 94.5% of transactions are under \$1,500. Ms. Galloway stated previously when someone got a new card; they would have to arrange a face to face training with her office where they would run over the policy. Ms. Galloway stated now we will have the employees read through the policy and take an online quiz graded by the Treasurer's office. Ms. Galloway stated once they pass the quiz they will get their card in person and sign for it. Ms. Galloway stated we will also have an annual, five minute quiz to remind people about policies. Ms. Galloway stated Ms. Bobbitt will receive reports to review transactions and make sure appropriate procurement practices are being used. Ms. Galloway stated her office will do an annual review of cardholder transactions to make sure everything is as it should be. Ms. Galloway stated she worked with the Auditor and Director of Purchasing to make sure they approved of the changes.

Commissioner Miller stated it sounds like an update was needed. Commissioner Miller stated she thinks the officials like this option for small transactions.

Ms. Galloway stated she thinks it provides appropriate flexibility. Ms. Galloway stated if they want to use it for a transaction over \$2,500 it just requires an email and approval to temporarily raise the limit. Ms. Galloway stated if you buy a lot of stuff online like IT, you have to have a lot of cards reissued due to fraud. Ms. Galloway stated Commerce Bank is really good about monitoring the account for fraudulent transactions. Ms. Galloway stated the day a fraudulent transaction shows up on the account, Commerce will have already contacted us.

Commissioner Elkin asked what department is the biggest P-Card user.

Ms. Galloway stated IT, the Sheriff's Department, and the Courts.

Commissioner Elkin stated he thinks from an efficiency standpoint it works really well for those departments.

Ms. Galloway stated IT has a lot of high dollar transactions, and the Sheriff's Department has a lot of low dollar, high volume transactions.

Commissioner Elkin stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available Commission meeting with an appropriate order for approval.
