PROPOSITION 1

Shall the Board of Education of the Sturgeon R-V School District, Missouri Board of Education borrow money in the amount of Two Million Five Hundred Thousand Dollars (\$2,500,000), resulting in no estimated increase to the debt service property tax levy, for the purpose of providing funds to complete improvements to the elementary and middle school facilities including new roofing, window replacement, walkways, canopies, new brick and brick replacement and electrical system upgrades; to test and remove asbestos; to complete other capital improvements district wide as approved by the Board of Education; and issue bonds, a portion of which may include Qualified School Construction Bonds and Qualified Zone Academy Bonds in an amount not to exceed the allocation from the Missouri Department of Elementary and Secondary Education, for the payment thereof? If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$1.27 per one hundred dollars of assessed valuation of real and personal property.

NOTICE is hereby given to the qualified voters of the Harrisburg R-VIII School District, Missouri (the "District"), in the State of Missouri, that an election will be held in the District on Tuesday, the 3rd day of November 2009, commencing at 6:00 a.m., and closing at 7:00 p.m., on that date, for the purpose of submitting to the qualified voters of the District the following proposition, to-wit:

PROPOSITION 1

Shall Board of Education of the Harrisburg R-VIII School District, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of One Million Three Hundred Thousand Dollars (\$1,300,000) for the purpose of providing funds to complete the necessary facility improvements, repairs, energy efficient upgrades, and

technology enhancements to school facilities; and issue bonds, a portion of which may include Qualified School Construction Bonds and Qualified Zone Academy Bonds in an amount not to exceed the allocation from the Missouri Department of Elementary and Secondary Education, for the payment thereof? If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$1.15 per one hundred dollars of assessed valuation of real and personal property.

NOTICE is hereby given to the qualified voters of the North Callaway County R-I School District, Missouri (the "District"), in the State of Missouri, that an election will be held in the District on Tuesday, the 3rd day of November 2009 commencing at 6:00 a.m., and closing at 7:00 p.m., on that date, for the purpose of submitting to the qualified voters of the District the following proposition, to-wit:

PROPOSITION K.I.D.S.

Shall the Board of Education of the North Callaway County R-I School District, Missouri, borrow money in the amount of Two Million Five Hundred Thousand Dollars (\$2,500,000) for the purpose of providing funds to complete heating, ventilation and air conditioning upgrades; to complete safety and security, remodeling and repair improvements to the existing facilities of the District in accordance with the recommendations of the District Facilities Planning Committee; and issue bonds, a portion of which may include Qualified School Construction Bonds and Qualified Zone Academy Bonds in an amount not to exceed the allocation from the Missouri Department of Elementary and Secondary Education, for the payment thereof resulting in an estimated increase to the debt service property tax levy of \$0.07 per one hundred dollars of assessed valuation? If this proposition is approved, the adjusted debt service levy of the School District is estimated to increase from \$0.5922 to \$0.6622 per one hundred dollars of assessed valuation of real and personal property.
