

TERM OF COMMISSION: October Session of the August Adjourned Term

The regular meeting of the County Commission was called to order at 2:00 p.m. Commissioner Vogt presided over the meeting.

**SUBJECT: Treasurer's Report on August, 1996**

Treasurer Kay Murray reported on the reconciliation of the bank statement and cash and investments for the month of August, 1996.

Commissioner Vogt stated the Boone County Group Homes and Family Support Board is very pleased with investments made on their behalf by the Boone County Treasurer.

**SUBJECT: Proposed Revision of Adopt-A-Road Program Policy**

Public Works Department Director Frank Abart stated the proposed revision makes it easier for individuals and groups to participate in the program. The policy currently requires brush control, mowing, and litter removal. The revision allows an individual or group to select activities they wish to perform. Most people are only interested in providing litter control. The Road and Bridge Advisory Committee approved the revision.

Commissioner Miller moved that the County Commission of the County of Boone adopt the revised Adopt-A-Road Program, identified as Section 150 of the Boone County Road Policy. The revised policy is attached.

Commissioner Vogt seconded the motion. Motion passed unanimously. **Order 528-96.**

**SUBJECT: Request to Adopt Roby Farm Road**

Mr. Abart stated Marjorie McDermott would like to adopt the entire length of Roby Farm Road. She and other residents would provide litter control on the road. The department reviewed the policy with the group and recommends approval of the request. The group plans to provide a name for use on the sign to be placed on the road, indicating its adoption.

Commissioner Miller moved that the County Commission of the County of Boone approve a request by a group of local citizens to participate in the Adopt-A-Road Program by providing litter control on Roby Farm Road. Marjorie McDermott is the contact person for the group.

Commissioner Vogt seconded the motion. Motion passed unanimously. **Order 529-96.**

**SUBJECT: Reports from Commissioners**

Commissioner Vogt reported on a meeting held yesterday regarding placement of the statue in the Government Center fountain. Most of the plaza project should be finished in December. The contractor wants to coordinate work on the exterior fountain with work on the interior fountain.

Commissioner Miller complimented Columbia Daily Tribune reporter Becky Burns on her article on placement of the statue in the fountain. The article was very informative and helped her understand the work which will take place.

Commissioner Miller reported on her attendance at the Missouri Commission On Intergovernmental Cooperation. The group looks at programs where intergovernmental cooperation could make the program work more smoothly. Some issues discussed were regional correctional facilities, welfare reform and personal property declarations.

The meeting adjourned at 2:30 p.m.
