# Purchasing

Dave Eagle, Purchasing, was present on behalf of these items.

# 1. 100-2008 – Drug and Alcohol Testing Services (first reading)

Mr. Eagle stated Purchasing requests permission to utilize the City of Columbia cooperative contract for Drug and Alcohol Testing Services with Mid-Missouri Drug Testing of Ashland, Missouri. We have currently been utilizing the City's contract for this service since 2002.

The initial term is through March 31, 2009, and the contract includes four one-year renewals. This is a county-wide term and supply contract.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

# **2.** Amendment Number Three – 55-27SEP05 – Electronic Monitoring Systems and Equipment (first reading)

Mr. Eagle stated the changes to this contract were per request by Pete Bakutes, Court Services Supervisor. The amendment increases our inventory on hand of the Sobrietor Shelf Units from two to three and the GPS Tracking Units from one to three. In addition, we're increasing the spare allowance from 20% of active days billed to 30% of active days billed. These amendment changes will decrease the amount of money that we are spending on spare inventory.

Invoices will continue to be paid from Department 1241 – Juvenile Office, and 1210 – Circuit Court Services, Account 71600 – Equipment Leases and Meter Charges.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

# **3. Budget Revision for Advertising (first reading)**

Commissioner Elkin stated by statute we have to advertise our sole source vendors every year. This revision will cover those advertising expenses.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

#### **Public Works**

#### 4. Authorization to Enter Into Easement Acquisition Agreements

Ms. Meighan stated this was discussed at the last work session. It will allow the Liaison Commissioner (or another Commissioner in his or her absence) to sign easement acquisition agreements up to \$4,500. Typically, most agreements fall under that amount.

Commissioner Elkin moved on this day the County Commission of the County of Boone does hereby grant the Public Works Liaison Commissioner (or another Commissioner acting in his or her absence) the authority to enter into agreements for the acquisition of easements in an amount up to \$4,500 per contract to be paid from Road and Bridge Funds.

# **5.** Budget Amendment for the Fostering Court Improvement JCIP Sub-Grant (first reading)
