
Now on this day the County Commission of the County of Boone does hereby approve a request by Robert L. Kinkead on behalf of Rex L. Kelly to rezone f22.38 acres, more or less, from A-2 (Agriculture) to M-LP (Planned Industrial) located at 7841 E ABC Ln, Columbia and with the following conditions:


1. Provide landscaping and buffer along southeast property line a distance of 200 feet that consist of Bradford Pears, Pin Oaks, and Red Cedar trees.
2. Plant Red Cedar trees along the east, north and west boundaries of the entire property, spaced no more than 30 feet apart.
3. Property lines on the east, north and west boundaries shall be protected with a 25' buffer, which is to remain either in a natural, undisturbed condition or be landscaped.
4. Uses permitted on lot 1 include: consignment vehicle auction and auction house.
5. Uses permitted on lot 2 include motor home sales, heavy equipment sales and rental, mobile home sales, farm implement sales and services, and rental business.
6. There may be up to four, free standing signs indicating the name of the business. The size of the signs shall not exceed 20' by 10'. These signs may not be used to advertise any off-premise business or attraction.
7. Dust free parking and driveway access to be provided on south side of property within 12 months of location and opening for business. Storage lots located to the north of the existing building may be gravel.
8. Final Development Plan to be prepared in accordance with zoning regulations.
9. The future development of lot 2 or a change in use of lot 1 may require submission of additional details, such as traffic analysis, storm-water control plans or other requirements based upon the proposed use.
