


Now on this day the County Commission of the County of Boone does hereby approve the following recommendations from the Job Classification Committee:

- Establish a "GIS Analyst II" classification class code 105301, pay range 43, classified as FLSA non-exempt.



Recommendations from Job Classification Committee

The Job Classification Committee met on November 5, 2015, to review and discuss a newly created position of Deputy Director, Emergency Management, a newly created position of Security Technician, and a proposal to divide the existing position of GIS Analyst into GIS Analyst I and GIS Analyst II. The Committee agreed to bring forward the following recommendations to the Commission:

Establish a "Deputy Director, Emergency Management" classification (class code 408301) on pay range 46, classified as FLSA exempt.

Pay range 46 has a minimum salary of \$50,481.60 and a maximum salary of \$75,732.80.

Establish a "Security Technician" classification (class code 304150) on pay range 37, classified as FLSA non-exempt.

Pay range 37 has a minimum salary of \$40,435.20 and a maximum salary of \$60,652.80.

Rename classification 105300, "GIS Analyst," as "GIS Analyst I" and modify the pay range for the classification from pay range 35 to pay range 39.

Pay range 39 has a minimum salary of \$42,473.60 and a maximum salary of \$63,731.20.

Establish a "GIS Analyst II" classification (class code 105301) on pay range 43, classified as FLSA non-exempt.

Pay range 43 has a minimum salary of \$46,883.20 and a maximum salary of \$70,345.60.


