Subject: Purchasing Department

Debbie Crutchfield, Purchasing Department Office Specialist, was present on behalf of these items.

A. Second Reading and Award of Bid 15-23MAR04 (Used Vehicle)

Debbie Crutchfield stated the Sheriff's department and the purchasing department have reviewed the bid received for the above referenced bid. We recommend awarding to Joe Machens Ford for a 2002 Ford Explorer for being the lowest and best bid meeting our minimum requirements. This vehicle is also available for immediate delivery. Total contract amount is \$21,500.00 to be paid from department 2500 account 92400.

Subject: First Reading of Engagement Letter for KPMG Audit Services – FY2003

June Pitchford stated this is a letter of engagement with KPMG for the external audit for FY2003. The fees for this audit will be more than last year due to GASB 34 standards. This audit will cost \$82,000 which was within the amount budgeted for this year. This reflects a 15% increase from the FY2002 audit.

Mrs. Pitchford presented the Commissioners with a letter from Jacqueline Dippel, Partner with KPMG, explaining the increase in the cost.

Mrs. Pitchford noted she contacted the City of Columbia to see what their increase was for their external audit. The City of Columbia's increase in audit fees was approximately 38%. She noted there are differences in way the audit is reported between the City and the County.
