RE: Request for Proposal 21-06JUN23 – Elevator Maintenance Services

Request for Proposal 21-06JUN23 – Elevator Maintenance Services closed on June 06, 2023. Three bid responses were received:

- 1. TK Elevator Corporation,
- 2. KONE Inc., and
- 3. Otis Elevator Company.

The three proposals have been evaluated by an Evaluation Team consisting of: Johnny Mays, Director of Facilities Maintenance, Jody Moore, Deputy Director of Facilities Maintenance, and Robert Summer, Senior Facilities Maintenance Technician. The Evaluation Team met three times to discuss and analyze each offeror's proposal.

One round of negotiations was pursued with each offeror and the Best and Final Offers were considered in the evaluation and scoring process. Paragraph 4.5.4 and its sub-paragraphs (a) through (d) addressed the County's ability and approach to negotiation of the proposals.

All three proposals have been found to be responsive according to the mandatory terms and conditions of RFP 21-06JUN23. A subjective evaluation was conducted by the Evaluation Team and was weighted into two categories: Experience, Reliability, & Expertise, and Method of Performance. Each category in the subjective scoring was given a maximum of 25 points.

Cost evaluations were conducted by the Purchasing Department and given a maximum score of 50 points to the lowest offeror. Cost points were not shared with the Evaluation Team until after subjective scoring was completed.

Subjective scores were added to the Cost scores for a total score for each offeror. Attached is the Score sheet with the total points awarded to each offeror.

Otis scored a total of 97 points, KONE, Inc. scored 93 points, and TKE scored 79 points.

The recommendation for the award is to Otis Elevator Company as the highest-scoring offeror. The contract period will run from the date of award through one year, with four (4) optional renewals.

This is a Term and Supply contract for Facilities Maintenance. Payments for services will reference department 6100 – Facilities Maintenance Building Maintenance, account 60050 – Equipment Services Contract with \$8,400 budgeted; department 2705 – 911/Emergency Management Facilities Maintenance Building Maintenance, account 60050 – Equipment Service Contract with a budgeted amount of \$2,160 for 2023.

# **Evaluation Report for Request for Proposal: 21-06JUN23 – Elevator Maintenance**

#### **SUMMARY:**

The Evaluation Committee initially met on June 12, 2023, and again on June 14, 2023, to review the subjective scoring process and procedures for the RFP. After the meeting on June 14, the Evaluation Committee drafted a list of questions/concerns for the offerors to clarify; The Offerors returned proposal clarifications as of June 20th, 2023. The questions asked were regarding the notification timeline before on-site visits by the vendor, and the turn-around time from the on-site visit to the County's access to the service report (Q&A document attached). Requests for Best and Final Offers were sent to TKE, KONE, Inc., and Otis Elevator Company on 6/23 to be returned no later than 11:00 am on 6/28.

After a meeting on 6/29/23, the evaluation committee finalized their subjective scoring, which favored Otis Elevator Company. Scoring was based on each company's history, experience, expertise, and methods of performance as noted and outlined above. Otis Elevator Company has 170 years of industry experience and expertise, a portfolio of large accounts, and easily accessible service reports and invoicing via their "eService" platform. Along with a positive, long-term reference, reliable service history, and multiple methods of contact, Otis Elevator Company scored 49 out of 50 in the subjective evaluations.

Cost evaluations were also conducted. It is important to note that TKE's cost analysis was not directly comparable to Otis Elevator and KONE Inc., as TKE did not submit a set, one-time, price for section 5.2.7 for the Over Speed Valve Test Inspection. Without factoring in this expense, TKE's pricing was still significantly higher than their competitors; the County felt it was unnecessary to request a more defined/direct quote for the one-time Over Speed Valve Test.
