Interior Window Cleaning Services

Request for Bid 13-14MAR23 – Exterior and Interior Window Cleaning Services closed on March 15, 2023. Four bid responses were received.

Recommendation for the award is to Shark Window Cleaning, LLC of Hartsburg, Missouri for offering the lowest and best bid of the responsive bid responses received.

Bid responses received from Riverside Restaurant dba Clean Slate Cleaning and NSM Highrise LLC, dba Squeegee Squad were non-responsive due to bidding *a per window cleaning* versus bidding what the bid required of a *total window cleaning project/location*. We did not provide the number of windows per building, so it was impossible to know their total bid price per building.

Cost of base bid for exterior windows of the Government Center, Emergency Communication Center, Annex Building, and Courthouse that will be cleaned annually is \$6,365.00. Alternate bid for interior windows of the Government Center and Emergency Communication Center will be cleaned as needed (not annually) for \$1,600.00. Invoices will be paid from department 6101 – FM Housekeeping & Custodial Services, account 60125 – Custodial/Janitorial Services. \$5,800.00 is budgeted for 2023. Per Facilities Maintenance, there are additional funds across class 6 as a whole that will cover the additional cost.
