Request for Bid 14-16MAR23 – Sodium Chloride (Rock Salt) Term and Supply closed on March 16, 2023. Three bids were received.

This was a bid issued for the Mid-Missouri Public Purchasing Cooperative. Participants included Boone County Road & Bridge, University of Missouri, Cities of Centralia, Hallsville, Ashland, and Columbia. Recommendation is for lowest and best bid to Independent Salt Company of Kanopolis, Kansas. Each participating agency will prepare their own contract.

Boone County's contract includes pre-fill at \$80.87/ton for a total of \$34,369.75 for 2023. The replenishment sodium chloride will be ordered as needed @ \$83.87/ton. Invoices will be paid from department 2040 – R&B Road Maintenance, account 26302 – Road Salt. \$235,000.00 is budgeted for 2023.
