

TERM OF COMMISSION: December Session of the November Adjourned Term

PLACE OF MEETING: Boone County Government Center Commission Chambers

The Presiding Commissioner called the meeting to order at 9:30am.

Subject: Adopt the Resolution for the award of 55-02NOV00 Fairway Meadows East Pump Station and ABC Labs Sanitary Sewer Extension to Capital Railroad Contracting, Inc.

Tom Ratermann, General Manager stated that Boone County is the owner on this project and therefore must adopt the Resolution. He stated that the award is dependent on the three items listed in the Resolution. He noted that the \$17,000 deduct was for the Smith and Loveless Pump Station alternate and the additive cost of \$7,500 was for the totalizing flowmeter.

Commissioner Vogt stated that the pump station and sewer extension would be an added benefit to the neighborhood.

Commissioner Stamper asked what the budget was on this project.

Tom Ratermann stated that it was over \$300,000, which was still a very good price.

Commissioner Vogt moved to adopt the attached Resolution for the award of 55-02NOV00 Fairway Meadows East Pump Station and ABC Labs Sanitary Sewer Extension to Capital Railroad Contracting, Inc. and authorize the Presiding Commissioner to sign the document.

The Resolution read as follows:

NOW on this 19th day of December, 2000, the County Commission of the County of Boone met in session and adopted the following resolution:

WHEREAS, the County of Boone has duly advertised for competitive bid of the construction of the project known as Fairway Meadows East Pump Station and ABC Labs Sanitary Sewer Extension, and

WHEREAS, Capital Railroad Contracting, Inc., was the apparent lowest and best bid submitted,

NOW THEREFORE BE IT RESOLVED that the County of Boone hereby awards the contract for the construction of the project known as Fairway Meadows East Pump Station and ABC Labs Sanitary Sewer Extension to Capital Railroad Contract, Inc., of Columbia, Missouri, in the base amount of \$281,710.16 less the Smith and Loveless Pump Station alternate for a deductive cost of \$17,000.00 plus the totalizing flowmeter for an additive cost of \$7,500.00 and total contract price not to exceed \$272,210.16 and subject to (1) execution of contract documents by the Presiding Commissioner of Boone County an authorized representative of Capital Railroad Contracting, Inc., (2) submission and approval of required bonding documents and insurance certificates, and (3) approval by the Missouri Department of Natural Resources of contract award requirements for participation in the Missouri State Revolving Fund.

SO RESOLVED the day and year first above written; the Presiding Commissioner and County Clerk of the County of Boone being hereby authorized to sign this resolution on behalf of the County Commission of the County of Boone.

Commissioner Miller seconded the motion.

There was no discussion.

Subject: Award bid 57-29NOV00 Radio and Auxiliary Equipment-Installation Term and Supply

Marlene Ridgway presented the following recommendation:

The department and I have reviewed the 4 responses submitted for the Radio and Auxiliary Equipment-Installation, Maintenance and Services and recommend awarding the bid to Chariton Valley TriStar Communications for having the lowest and best bid meeting the minimum specifications.

This is a term and supply contract, hence no need for purchase orders.

Subject: Letter from the U. S. Department of Agriculture regarding the proposed amendment to the Mark Twain National Forest Land and Resource Management Plan (Forest Plan) regarding the management of Indiana bats

Commissioner Stamper stated that the proposed amendment would change the management direction for some National Forest lands around Indiana bat hibernacula (caves) and in areas where reproductively active females have been found. Commissioner Stamper submitted the letter for the public record and asked that it be posted

Commissioner Reports

Commissioner Stamper

Commissioner Stamper stated that he had a brief discussion with the Sheriff about converting one of the vacant Corrections positions into a Patrol Officer position. He stated that the Sheriff seemed to be open to that suggestion. He stated that the Sheriff also expressed that he would like to have another Patrol Officer included in the 2001 budget, for a total of three officers. Commissioner Stamper stated that he informed the Sheriff that the County Commission would only be able to approve the two, Patrol Officers at the most due to budgetary constraints.

Commissioner Stamper stated that Governor Roger B. Wilson invited all of the Boone County elected officials to a luncheon at the Governor's Mansion. He expressed appreciation for the invitation from Governor Roger Wilson.

Commissioner Vogt commented that it was a very lovely luncheon. She stated that the Governor stated that every citizen in the state of Missouri should have that same opportunity since the Governor's Mansion belongs to the entire state.

Commissioner Miller stated that she attended the CATSO meeting on December 14, 2000. She stated that there was a great deal of concern expressed by a neighborhood in Commissioner Vogt's district. She stated that there was enough concern by the public and also by the County Commission regarding the 740 interchange to table the plan. She stated the CATSO representatives would request a six-month extension from the federal government to review several items within the plan.

Commissioner Miller noted that attendance at the CATSO meeting was very good. She also stated that the meeting was televised. She noted that there is still time to submit written comments on the plan.

Commissioner Vogt thanked Commissioner Miller for attending the meeting. She stated that the CATSO plan is very important to the future of the people of Boone County

Commissioner Miller stated that someone made a recommendation to adopt the plan and then amend it at a later. She noted however that both she and Mayor Hindman expressed discomfort with that option, so the plan was tabled.
