The meeting was called to order at 9:30 a.m.

Subject: Purchasing Department

Marlene Ridgway, Purchasing Department Buyer, was present on behalf of these items.

A. Second Reading and Award of Bid 83-10DEC02 (Service Trucks)

Marlene Ridgway stated the department is recommending award to Tom Boland Ford for a 2003 Ford F550 Super Duty Regular Cab 4x4. The department is also requesting the approval of disposal of a 1996 Ford ½ Ton 4x4. The total contract value including tradein is \$65,176.00.

Commissioner Elkin stated the reason only one bid was submitted is because these trucks are specialty trucks and there are not that many dealers that have the trucks in stock.

There was no further discussion.

Commissioner Elkin moved to award bid 83-10DEC02 for Service Trucks to Tom Boland Ford. The County Commission of the County of Boone does hereby approve the disposal through trade-in of a 1996 Ford ½ Ton 4x4 (Fixed Asset Tag #10601).

B. Second Reading and Award of Bid 82-10DEC02 (Tandem Axle Trucks)

Marlene Ridgway stated the department is recommending award to Al Scheppers Motor Company. The total contract value for three trucks including trade-in is \$313,761.00.

The department is requesting approval for disposal through trade-in of a 1993 John Deere 670B Motor Grader (Fixed Asset Tag #7867). The total contract value including trade-in is \$142,500.00

Commissioner Elkin moved to award bid 80-10DEC02 for a Motor Grader to Tri-State Construction Equipment Company. The County Commission of the County of Boone does hereby approve the disposal through trade-in of a 1993 John Deere 670B Motor Grader (Fixed Asset Tag #7867).

Subject: Public Works

David Mink, Public Works Director, was present on behalf of these items.

A. Second Reading and Approval of Contract with Mitzel and Scroggs Architects

David Mink stated this is a second reading for the Consultant Services Contract with Mitzel and Scroggs Architects for the Courthouse Tile Project.

Commissioner Miller stated Mitzel and Scroggs did the study and asked if they would begin the bidding process now. Mr. Mink stated that is correct and noted this will also include construction administration during the construction phase. The amount of the contract is equal to what was budgeted, \$7,200.00.

Commissioner Elkin asked if it was their intention to do work on the weekends or also during the week. Mr. Mink stated this will be part of this phase of the project, to establish a schedule for the project. The amount that was estimated included the cost of some off hour work.
