## Subject: Planning and Zoning

Commissioner Schnarre noted that during Planning and Zoning sessions, the Commission will receive a report from staff and then the Commission will have the opportunity to ask staff any questions. The Commission will then move to a presentation from the applicant or agent of the applicant on behalf of their request. After that, the Commission will convene a public hearing where any testimony in favor of or in opposition to will be welcome. Following the public hearing, the Commission will discuss the issue and then vote on the issue.

Stan Shawver, Director of the Planning and Building Inspection Department, stated that the Boone County Zoning Regulations and the Subdivision Regulations are entered into the record. (note - the file copy is retained in the Planning and Building Inspection Department).

# A. Request by GM Columbia Properties LLC to vacate and re-plat lots 1, 2, 23, 24, 25, 40, 41, 42, 43, 44 and 45 of Concord Estates Plat 1

Stan Shawver stated the department received a petition to vacate eleven lots in Concord Estates Plat 1 and re-plat them into three lots.

Section 1.8.1.3 of the subdivision regulations require the County Commission to hold a public hearing in order to consider any petition to vacate and/or re-plat, taking into consideration character of the neighborhood; traffic conditions; circulation; the proper location and improvement of streets and roads within and adjacent to the subdivision; property values in the subdivision; public utilities; facilities and services and the re-plat will not generally adversely affect the health, welfare, or safety of persons owning or possessing real estate within the subdivision to be vacated or surrounding real estate.

Chad Sayre was present on behalf of GM Columbia Properties.

Chad Sayre stated this request to vacate is in compliance with the revised lot lay out of the preliminary plat. It complies with the approved street alignment, as far as concept. The lots being vacated are owned by GM Columbia Properties. Mr. Sayre explained the street lay out.

Commissioner Schnarre asked if this request is being done to cul-de-sac the streets. Mr. Sayre stated that is correct and to expand the right-of-way.

Commissioner Schnarre asked if the streets would not be abandoned immediately. Mr. Sayre stated the connection will remain in a temporary form. When they re-plat, they will work with staff to keep the public access open with the existing right-of-way then they will come back and vacate the right-of-way.

Commissioner Elkin asked if that will ultimately be closed off. Mr. Sayre stated that is correct.

Commissioner Elkin asked if those roads have to remain open until the other network of streets is opened. Mr. Sayre stated that is correct.

Commissioner Elkin asked about the re-platting process. Mr. Sayre stated they will come back to comply with the preliminary plat. There will be three new lots. The one lot not owned by GM Columbia Properties has to be vacated and when it is re-platted is when the right-of-way issues will be cleared up. Before that can happen, there has to be an alternate access to the subdivision.

Mr. Sayre discussed the roads being a possible candidate for bonding.

Commissioner Schnarre opened the floor for a public hearing on this request.

There was no one wishing to speak on this request.

Commissioner Schnarre closed the public hearing.

Commissioner Elkin moved to approve the petition submitted by GM Columbia Properties LLC to vacate and re-plat lots 1, 2, 23, 24, 25, 40, 41, 42, 43, 44 and 45 of Concord Estates Plat 1. Said vacation is not to take place until the re-plat is approved.

Commissioner Schnarre seconded the motion.
