The meeting was called to order at 9:30 a.m.

1. Purchasing

Melinda Bobbitt, Purchasing was present on behalf of these items

A. First Reading - 62-24AUG06 Wheel Loader

Ms. Bobbitt reported the bid for a Wheel Loader closed on August 24, 2006. Six bids were received. Purchasing and the Public Works Department recommend award to Crown Power and Equipment for submitting the low bid.

Total cost of the contract is \$54,577.00 including a 60 month/4000 hour full machine warranty to be paid out of department 2040 - PW Maintenance Operations, account number 92300 – Replacement Machinery/Equipment. The budgeted amount for this purchase was \$73,000.00.

The Purchasing Department also requests permission to trade in one (1) 1996 Komatsu WA120-1 Loader (including forks) with approximately 2100 hours.

There was no discussion and no public comment.

Commissioner Schnarre stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available meeting with an appropriate order for award.

B. First Reading CenturyTel Contract

June Pitchford, Auditors office was present on behalf of this item.

Ms. Pitchford stated every year the County Commission is requested to renew the 24/7 maintenance coverage on the E911 equipment in joint communications. The equipment is purchased and maintained through the E911 fund which is a funded by the E911 tax proceeds.

This was originally reviewed and approved by County Counsel in May. We have resolved the residual issues. We do have an 8% increase due to the additional phone system.

C. RFP Award Recommendation /Fairgrounds

June Pitchford, Auditors Office was present on behalf of this item.

Ms. Bobbitt reported the Request for Proposal for *Market Assessment and Financial Feasibility Study of the Boone County Fairgrounds* closed on August 3, 2006. Four proposal responses were received.

The evaluation committee recommends award to Markin Consulting per their attached evaluation report. The cost of this contract \$34,480. Contract will be paid out of department 2120 – Fairgrounds Maintenance Fund, account 71101 – Professional Services.

Commissioner Schnarre asked if Commissioner Elkin or Ms. Pitchford had any comments.

Commissioner Elkin stated they had received four RFP's and had a lengthy phone interview with Mr. Markin. He not only answered their questions, but when above and beyond in sharing the information. His firm has a lot of experience doing similar projects. The committee felt he has a small firm and would be more involved first hand.

Invoices from this term and supply contract will be paid out of department 2045 – PW-Design and Construction, account 23001 – Printing. \$2,603 remains in the budget at the time of this writing.
