The meeting was called to order at 9:30 a.m.

Purchasing

Heather Turner, Purchasing was present on behalf of these items.

A. Vehicle Disposal

Ms. Turner reported a list of vehicles for surplus from the Sheriff Department was read in commission and approved on October 10, 2006, commission order 403-2006. A correction to that Memo needs to occur.

Commissioner Schnarre stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available meeting with an appropriate order for award.

B. First Reading 55-27SEP05 – Electronic Monitoring Services

Ms. Turner stated the Purchasing Department received a request from Pete Bakutes, Court Services Supervisor, to amend the Electronic Monitoring Services contract with BI, Incorporated to include Exacutrack AT On Demand. This amendment would allow Court Services to utilize new technology and begin placing offenders on an active GPS monitoring program which would track and report recent location coordinates of offenders as well as immediately report the presence of offenders in areas which are considered "off limits".

The Best and Final Offer Response submitted during the RFP process by BI, Incorporated included a price for active GPS in the event the County chose to add it at some point in the future, however, the attached amendment includes a price for active GPS technology which is much less than what was originally proposed due to the increased utilization of active GPS technology by Court Services throughout the country.

This is a term and supply contract paid out of Departments 1241-Juvenile Office and 1210-Circuit Court Services, Account Number 71600 – Equipment Lease and Meter Charges. There is approximately \$65,000.00 budgeted for FY '07 for Electronic Monitoring Services.

Commissioner Schnarre asked what the cost was per day.

Ms. Turner responded \$7.10 per day.

He then asked what the current system they are using, without the GPS costs per day.

Mr. Pete Bakutes, Court Services Supervisor stated the basic system runs around \$3.00 and they also have a passage GPS

Commissioner Elkin thought the individuals had to pay one hours wages per day.

Mr. Bakutes confirmed that it would either be one hour at minimum wage or one hour that they actually make, which ever is more.

Commissioner Miller asked by having active GPS will the courts won't allow more people to be on home detention, having less people out of the jail. More people qualify with active GPS who won't qualify now.

Mr. Bakutes said it was very hard to predict. On some of the marginal cases they might be

more likely to recommend to put the person on home detention with the GPS.

There was no public comment.

Commissioner Schnarre stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available meeting with an appropriate order for award.

C. First Reading 78-26OCT06 – Image Scanners: Production and Large Format

Ms. Turner reported the bid for Image Scanners: Production and Large Format closed on October 26, 2006. Six bids were received. Purchasing and the Information Technology Department recommend awarding by item as follows:

- Item #1 (Colortrac CX40E Large Format Scanner) with all options, including an additional 2 year onsite maintenance agreement, to the low bidder, Titian Consulting for a total cost of \$11,544.00.
- Item #2 (Fujitsu fi5750C Scanner) with all options to the low bidder, CDW Government for a total cost of \$6,492.00.

The grand total for all equipment and maintenance is \$18,036.00 to be paid out of department 2045 – Public Works Design and Construction, Account Number 91301 – Computer Hardware. The original budget for this project was \$33,000.00 which includes other computer hardware to be supplied by the IT Department.

2. Post Bond Assessment for Applewood Creek Road

Mr. John Watkins, Public Works and Ms. Patricia Lensmeyer, Collector were present on behalf of these items

Mr. Watkins stated all three have been completed and this was just the last thing to do.

Ms. Lensmeyer wanted to bring attention to the first paragraph. In order to get the bills out on time the collectors' office took the information that was available at the time. The first year would be the only one which has a different amount. The balance was distributed among the remaining years as not to create a burden to any homeowner.

Commissioner Miller moved now on this day the County Commission does hereby compute the **Final Post Bond Assessment** of the road improvement project for the **Applewood Creek** Neighborhood Improvement District as certified by the Auditor to be \$ 16,061.82.
