The meeting was called to order at 1:30 p.m.

Auditor

June Pitchford, Auditor, was present on behalf of this item.

1. FY 2009 Budget Update

Ms. Pitchford stated she thought it would be helpful to inform the Commission and the public about where we are financially at this point before the budgeting process begins. She stated the 2008 budget reflected a possible additional 2 cent tax levy to help defray election costs. As it turns out, that levy is not needed. The projected sales tax revenues for 2008 will not meet the budget. We are running a half percent negative growth right now.

Ms. Pitchford presented the current budget report for the General Fund. A copy of that report may be obtained at the Boone County Clerk's Office in Room 236 of the Roger B. Wilson Boone County Government Center.

Stan Shawver, Director of Planning and Building, stated everybody is worried about the state of the economy. He stated his employees have worried about whether the County will have to look at layoffs.

Ms. Pitchford stated that is not anything that she is looking at, but everybody is seeing the same thing. We cannot continue the same expenditure patterns if the revenue side is decreasing. As hard as it is to recruit, train, and retain people, it is to our advantage to try to weather the storm. She stated it is her opinion that nobody should say that the county will never be faced with making staff changes.

Commissioner Elkin stated he lays awake at night thinking about the possibility of layoffs, and it makes him sick to think about it. He stated speaking for himself, before we got to the point of layoffs, he would want to look for other positions they could be moved to. There are always vacancies in other positions, so if a building inspector has no inspections to do, we could reassign them before laying them off.

Commissioner Pearson stated layoffs are the type of thing that happens in state agencies when there is a downturn. In the case of the general revenue, most of that is going to pay salaries.

Ms. Pitchford stated about 58% goes to salaries.

Commissioner Pearson stated if there are vacancies, maybe we don't fill those, or we shift resources. When you get through the downturn, then you readjust. The last thing we want to try to do is to lay people off. We want to preserve jobs for a number of reasons.

Commissioner Miller stated that is why we have been so careful about adding people, so we won't be in that position to have to lay people off. We value the people we have. We have to realize that we are in this together and we cannot be territorial. We need to look at what we can do and what we cannot do. It might get to the point where we will have to raise property taxes if we cannot cut anything else out. We have to recognize that and we have to have the support of everyone if we get to that point.

Commissioner Pearson stated people say that governments should work like businesses. He stated he has never really believed that. Governments provide a lot of services, and there is an expectation that the level of service will be maintained. It is very hard to do that when a big part of what you are spending your money on is staff. You have to be very careful in terms of figuring out what we can do and how we can maintain our level of service while maintaining our staff.
