The meeting was called to order at 1:30 p.m.

#### **Public Works**

Derin Campbell, Director of Public Works, was present on behalf of these items.

#### 1. Catwalk Renovation & Construction with Additional Lighting (first reading)

Mr. Campbell stated this contract is for the engineering work for the renovation and construction of catwalks at the Public Works facility.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

#### 2. Owens School Road Bridge Project (first reading)

Mr. Campbell stated maintenance has fixed the pipes at this site about three or four times last year. The pipes are 30-40 years old and starting to fail. We are planning on putting a new drainage structure in place, and this is the engineering contract to get the engineering work done so we can move forward.

Commissioner Elkin asked if we know what kind of structure we are going to use yet.

Mr. Campbell stated they have a preliminary idea that it will be a large concrete box, but that is a very preliminary calculation. They have not done the survey work yet.

Commissioner Elkin asked what the advantage of a concrete box is over an arch culvert.

Mr. Campbell stated one thing is clearance. There is about nine feet from the existing road surface to the bottom of the channel.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

## 3. Variance Request for Addison Ridge Subdivision

Mr. Campbell stated the Road and Bridge Advisory Committee met in regards to this request, and a motion was made and passed that as long as Brush and Associates designed the island with proper drainage and a maintenance agreement was submitted to Public Works, then this would be satisfactory.

Commissioner Pearson stated at the meeting they had an original drawing and some suggestions were made to modify it, and the modifications were made. Based on that, they found it acceptable.

Commissioner Miller asked if it will be a raised or lowered median.

Dan Brush, Brush and Associates, stated it will be raised. He stated it will have a curb and gutter, and it will be more of a mound-type island.

Commissioner Pearson stated there will be a drain in it so the water wouldn't stay there and damage the road.

Commissioner Miller moved on this day the County Commission of the County of Boone does hereby accept the Road and Bridge Advisory Committee Recommendation of Variance Request:

For an island construction at the entrance of Addison Ridge Subdivision with the stipulation that the drainage design and maintenance agreement are completed to the satisfaction of Boone County Public Works.

Commissioner Elkin seconded the motion.

## 5. 06-26FEB09 – Heavy Trucks and Large Equipment Term and Supply (first reading)

Mr. Boldan stated the bid for Heavy Trucks and Large Equipment Term and Supply closed on February 26, 2009. Of the five bids received, Cross Midwest Tire was the low bid. Purchasing and the Public Works Department recommend award to Cross Midwest Tire for offering the lowest and best bid for Boone County.

This is a term and supply contract. Contract will be paid from Department 2040 – PW – Maintenance Operations, Account 59105 – Tires. \$100,000 is budgeted for this service.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

## 6. 54-30OCT08 – Grading MKT Trail (first reading)

Mr. Boldan stated commission order number 543-2008 approved award to Blacktop Paving, LLC in December of 2008 for bid 54-30OCT08 – Grading MKT Trail. The Purchasing Department received a letter stating that Blacktop Paving, LLC has gone out of business. Purchasing and the Facilities Maintenance Department recommend award to the next lowest bidder, C.L. Richardson Construction Co., Inc.

The price difference for awarding to C.L. Richardson Construction Co., Inc. is \$238.00 more.

This is a term and supply contract and invoices will be paid from Department 1610 – Parks & Recreation, Account 60400 – Grounds Maintenance. \$7,500.00 is budgeted for this service.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

## 7. 03-19FEB09 – Big Timber Overlay and Drainage Improvements (first read on 2/19/09)

Mr. Boldan stated the bid for Big Timber Overlay and Drainage Improvements closed on February 19, 2009. Four bids were received. Purchasing and the Public Works Department recommend award to Christensen Construction Company for offering the lowest and best bid for Boone County.

Total cost of contract is \$85,726.00 with a 10% contingency amount of \$8,572.60 for a Purchase

Order total of \$94,298.60. Contract will be paid from Department 2040 – PW – Maintenance Operations, Account 71100 – Outside Services. The budgeted amount was \$144,584.

Commissioner Elkin moved on this day the County Commission of the County of Boone does hereby award bid 03-19FEB09 – Big Timber Overlay and Drainage Improvements to Christensen Construction Company. It is further ordered the Presiding Commissioner is hereby authorized to sign said contract.

Commissioner Miller seconded the motion.
