Purchasing

Tyson Boldan was present on behalf of this item.

1. 43-16Aug10 Pre-Printed Envelopes (first reading)

Mr. Boldan stated the Bid for Pre-Printed Envelopes Term and Supply closed on August 16, 2010. Seven bids were received. Purchasing and the Collector's Office recommend award to Affordable Printing Solutions, for offering the lowest and best bid to the County. This is a term and supply contract. Contract will be paid from department 1150 – Information Technology and account 23001 – Printing. This account has \$14,125.00 in it and the estimated cost of this contract is \$8,029.94.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

Facilities Maintenance

Bob Davidson was present on behalf of this item.

2. Change Order for Facilities Maintenance (first and second reading)

Mr. Davidson stated this is change order # 1 for the Boone County Parking Lot project. There are many additions to this change order. First the area of the parking lot which is next to County Drive is in really bad shape. The asphalt has disintegrated right there. The second item is a request by the Sheriff to add an area next to the auto vacuum so they could wash cars and not block the driveway.

Commissioner Miller stated that was a pretty good idea.

Mr. Davidson stated yes. The next few items are deductions because of the selections we chose

in the plan. For example the County chose the rain garden instead of the French drain. Another addition was to add curbs in the parking lot to protect the grass. All of these together come to \$18,630.10.

Commissioner Miller asked what the contingency amount was for this project.

Mr. Davidson stated he believed 10%.

Commissioner Miller stated so the County is well within contingency.

Commissioner Pearson stated yes.

Commissioner Elkin asked if this would finish the project.

Mr. Davidson stated he believed so.

Commissioner Elkin moved on this day the County Commission of the County of Boone does hereby authorize Commissioner Ken Pearson to sign Change Order #1 in the amount of \$18,630.10 for the Boone County Jail Parking Lot project with Stockman Construction Corporation.
