- WHEREAS,* Wendy served as the legislative chair of the Missouri Association of County Clerks and Election Authorities and was the National Association of Counties representative on the U.S. Election Assistance Commission advisory board, contributing to many state and national election law reforms; and
- WHEREAS,* Wendy made every effort to equip Boone County with the most advanced elections technology, often through innovative use of grant funding, focusing on always providing citizens with the ability to register to vote, to be an informed voter and to cast their ballot in a secure way; and
- THEREFORE,* with our best wishes for the future let it be known that Wendy S. Noren is hereby recognized for her outstanding dedication and integrity during her years of service as County Clerk of Boone County, Missouri, for which all Boone Countians have benefited.
