

NOTICE OF SPECIAL ELECTION

City of Columbia, Missouri

Notice is hereby given to the qualified voters of the City of Columbia, Missouri, that the City Council of the City has called an election to be held in the City on Tuesday, November 3, 2015, commencing at six o'clock a.m. and closing at seven o'clock p.m., on the question contained in the following sample ballot:

PROPOSITION 1

Shall the municipality of Columbia, Missouri impose a sales tax of one-eighth of one percent, for six (6) years, for the purpose of providing funding for local parks for the municipality?

The current one-fourth of one percent local parks sales tax is scheduled to be reduced to one-eighth of one percent on March 31, 2016. Approval of this proposition would keep the local parks sales tax rate at one-fourth of one percent for an additional six (6) years.

The city intends to use this sales tax to fund projects in the city's parks, recreation and open space master plan including renovations and improvements to existing parks, development of neighborhood and community parks, development of trails and greenbelts, and the acquisition of land for parks, trails, greenbelts and open space preservation.

Notice is hereby given to the qualified voters of the Harrisburg R-VIII School District of Boone and Howard Counties, Missouri, that an election of said district will be held at designated polling places within the district on Tuesday, the 3rd day of November, 2015, commencing at 6:00 a.m., and closing at 7:00 p.m., on that date, for the purpose of submitting to the qualified voters of the district the following proposition, to-wit:

PROPOSITION 1

Shall the school board of the Harrisburg R-VIII School District be authorized to increase the operating tax levy for meeting the operating needs of the District by sixty-seven (67) cents per one hundred dollars of assessed valuation? Funds generated by the increased tax levy will be used for maintaining high quality instructional programs, materials and equipment; meeting the increased need for technology in classrooms; competitively recruiting and retaining quality teachers and staff; and meeting the increased costs of facilities maintenance, upkeep and improvements. If this proposition is approved, the adjusted operating levy of the school district is estimated to be \$ 4.0617 per one hundred dollars of assessed valuation.
