The meeting was called to order at 9:31 a.m.

#### **Subject: Sheriff's Department – First Reading of Contract for Substation**

Sheriff Ted Boehm was present on behalf of this item.

Sheriff Boehm stated this is a land use agreement with the Missouri Highway Commission. This agreement has been reviewed by the County Counselor.

This agreement is for land located at Highway 63 and 124 in northern Boone County, which is owned by the Missouri Highway Department. If the Commission signs this agreement, it would allow the Sheriff's Department to use the property for an undisclosed period of time. The Highway Department had plans at one time to build a maintenance facility at this location. Also during the discussion, if the Highway Department moves forward with the maintenance building, the Sheriff's Department could possibly have an office in that facility. These plans have been set aside at this time.

In the mean time, the Sheriff's Department would like to use this land. The Highway Commission has agreed to allow the Sheriff's Department to use the land for a substation.

Commissioner Schnarre asked if there was any cost involved. Sheriff Boehm stated there is no cost to the County for use of the land. He plans to place a mobile office on the land. The Department has received bids on purchasing or leasing a mobile office and he believes the department will lease a mobile office for a three year period.

Commissioner Elkin stated this is part of the Sheriff's overall goal to have better response time. It is to his understanding that the Sheriff would like to move forward with this agreement today. Sheriff Boehm stated that is correct. The Highway Commission is waiting for this document signed by the County Commission. Sheriff Boehm requested the Commission waive the second reading and approve this agreement today.

Sheriff Boehm noted after the Highway Commission has received the agreement, the department will meeting with the Highway Department's engineers to discuss the location for the mobile office on the property. The Sheriff's Department will be able to move forward with other items, such as sewer and driveway, while waiting on a decision on the

location of the office.

Commissioner Schnarre stated there are some County obligations to this lease, such as liability.

John Patton, County Counselor, stated this agreement has an indemnification clause and there is no insurance to cover this. While the lease is free, this is not without obligation.

The Commission acknowledged that the agreement had an indemnification clause required the County to indemnify and defend the Missouri Department of Transportation and that this obligation would not be insured according to legal counsel.

Commissioner Elkin stated he does not have any objections to moving forward with this item today.

Commissioner Schnarre asked why this should be approved today. Sheriff Boehm stated the sooner this agreement is to the Highway Commission, the sooner the work can begin to locate the mobile office.

Commissioner Schnarre asked what the funding source will be for this. Sheriff Boehm stated this will be paid from the Sheriff's Civil Process funds.

There was no further discussion on this item.

Commissioner Elkin moved to approve the Missouri Highways and Transportation Commission Facility Use Agreement for the Boone County Sheriff's Department Substation to be located at U. S. Highway 63 and Highway 124 in Northern Boone County.

Commissioner Schnarre seconded the motion.

There was no discussion and no public comment.

# A. First Reading of Utility Relocation Agreement for Olivet Road Reconstruction Project

David Nichols stated this is an agreement with Boone Electric Cooperative for the proposed Olivet Road Reconstruction Project. This is a not to exceed contract for

\$111,469.00. He will be bringing a water line relocation agreement forward soon for this project.

Mr. Nichols stated this project was budgeted for 2003 and believes this will be ready to go to bid soon.

Commissioner Schnarre noted he will be abstaining from a vote due to a conflict of interest and requested the Deputy County Clerk to authorize an Associate Commissioner to sign the agreement.

There was no further discussion on this item.

Commissioner Schnarre stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available meeting with an appropriate order for approval.

# **B.** First Reading of Utility Relocation Agreement for Scott Blvd Reconstruction Project

David Nichols stated this is an agreement with Boone Electric Cooperative for the proposed Scott Boulevard Reconstruction Project. This is a not to exceed contract for \$78,614.00.

Commissioner Schnarre noted he will be abstaining from a vote due to a conflict of interest and requested the Deputy County Clerk to authorize an Associate Commissioner to sign the agreement.

We further recommend awarding to Five Oaks Construction for having the best bid meeting our minimum specifications. Total cost of the base bid and Alternate 1 is \$922,000.00 to be paid from 4020 account 71201.
