## Subject: Public Hearing – Boone County Roadway Regulations Chapter I: Vehicular Traffic Regulations

John Patton, County Counselor, was present on behalf of this item.

John Patton stated this is updating and compiling all the speed limits for all County maintained roads so they can be easily located. These speed limits are in an appendix to the regulations. There has been a slight change in Section 1.4 to refer to the appendix.

Commissioner Schnarre opened the floor for a public hearing on this item.

## Subject: Central Missouri Counties Human Development Corporation – First Reading of Section 8 Voucher Program FY05 Budget

Barbara Johnson and Anita Sanderson, Central Missouri Counties Human Development Corporation, were present on behalf of this item.

Anita Sanderson stated they are presenting documents to be approved by the Commission and submitted for the HUD FY05 budget. This budget cycle begins on April 1, 2004. These documents have to be submitted this month.

Commissioner Elkin asked if there are any changes. Mrs. Sanderson stated there are no changes. The CMCHDC still handles 401 units in Callaway, Cole, Cooper, Howard,

Moniteau, and Osage Counties. The CMCHDC does not handle any units in Boone County, the Columbia Housing Authority handles all Section 8 housing in Boone County.

## **Subject:** Purchasing Department – Second Reading and Approval of Amendment #4 to Bid 01-24JAN01 (Electronic Monitoring Services)

Marlene Ridgway, Purchasing Department Buyer, was present on behalf of this item.

Marlene Ridgway stated this is Amendment Number Four for contract 01-24JAN01 for Electronic Monitoring Services and Equipment Term and Supply. The Court Services department is requesting the following changes to the contract:

- A loss or damage allowance of 5% that BI Incorporated will be responsible for per year.
- GPS tracking services at the rate of \$6.50 per day per unit. The participant of the program will be responsible for reimbursement of costs.
- BI Cellular Unit at a rate of \$3.50 per day per unit. The Cellular unit is designed to work with out a telephone line connected to the participant's home. The participant of the program will be responsible for reimbursement of costs.
- BI Profile program at no cost. This will enable the participant to update and report changes in status through the internet.

The original agreement is a county-wide term and supply contract utilized primarily by 1210- Circuit Court Services account 71600- equipment lease.
