2. Surplus: Fixed Asset Tag 14005 Digital Recording System from Commission Order 126-2009 (first reading)

Ms. Bobbitt stated the County purchased a new Digital Recording System for Public Safety Joint Communications in 2008 to replace fixed asset tag recorder 14005. Previous Public Safety Director Jim McNabb told us they would be ready to surplus the recorder being replaced in April 2010.

Zim Schwartze, current Director of Public Safety requests permission to retain this recorder to use as a backup recorder if/when there is a backup dispatch center. This recorder was approved for disposal on commission order 126-2009. May we now transfer this recorder to Public Safety Joint Communications?

3. Bid Award 33-17Jun10 Tomlin Hill Road Asphalt Overlay (second reading, first read on 6/17/2010)

Ms. Lensmeyer stated there were 513 and this is the most that they have had since she has held office. Ms. Lensmeyer stated her office is really successful on this because they do lien searches ahead of time and find people who have interest in these properties.

Commissioner Elkin moved on this day the County Commission of the County of Boone does hereby acknowledge the 2010 Tax Sale Surplus Report presented by the Boone County Collector in the amount of \$106,409.83. It is further acknowledged said funds shall be turned over to the Boone County Treasurer.

5. Change Order 2 for the Country Squire Sanitary Sewer Neighborhood Improvement District (first and second reading)

Mr. Lister stated the Commission should have a memo in front of them in addition to a change order for the Country Squire Sanitary Sewer Neighborhood Improvement District. When the contract did the final filling and grading, we realized there were quite a few manholes that were just a little too low and would potentially cause problems. The bid from the Contractor to put grade rings on to raise those manholes cost \$4,500.00. The manholes were \$250.00 each for eight man wholes. The total cost for us would be \$2,000.00 since this is part of the stimulus projects.

Commissioner Miller moved on this day the County Commission of the County of Boone does hereby authorize Commissioner Ken Pearson to sign Change Order #2 in the amount of \$2,000.00 for the Country Squire Neighborhood Improvement District.

6. DOVE Grant Application (fist and second reading)

Mr. Knight stated this application is for continued funding for Domestic Violence Enforcement Unit. This grant currently funds the partial salary for two prosecutors. Matching funds would be the portion of those prosecutor's salaries and benefits which is already being paid out of the Counties general fund. Mr. Knight stated they are also requesting that the two Recovery Act personnel that were hired back in September of 2009 be retained through this grant application. Mr. Knight stated they are requesting full salary and benefits for both of those positions from May 1st 2011 through December 31st of 2011. The funds for these two people will expire April 30th of 2011. The total grant request is \$179,741.08 with \$134,717.72 as federal funds and the General Revenue match is \$45,023.46.

Commissioner Elkin moved on this day the County Commission of the County of Boone does hereby approve the grant application for grant number 2008-VAWA-0061-OS Domestic Violence Enforcement Unit for the period starting on 1/01/2011 to 12/31/2011 in the requesting amount of \$134,717.72. It is further ordered the Presiding Commissioner is hereby authorized to sign said grant application.
