1. Abatement of property located at 465 E. Winter Street, parcel # 11-619-24-01-124.00 01 (first and second reading)

Senior Environmental Health Specialist Kristine Vellema was present on behalf of this item. Ms. Vellema stated this abatement was complaint driven. Ms. Vellema stated she could not get the property owners to sign for this notice, so she advertised it in the newspaper. Ms. Vellema stated she attempted to call the owners, but the number listed said it did not accept calls. Ms. Vellema stated she did not believe the property had been mowed all year. Ms. Vellema stated this property is located in the Clearview subdivision. Ms. Vellema stated the bid to mow the property is \$110. Ms. Vellema stated the mowers said they will have to hand trim the backyard because the mower won't fit through the gate.
