PURCHASE AGREEMENT FOR VIDEO CONFERENCING EQUIPMENT AND MAINTENANCE

THIS AGREEMENT dated the 30^{+4} day of 90^{-2} 2008 is made between Boone County, Missouri, a political subdivision of the State of Missouri through the Boone County Commission, herein "County" and Expedite Video Conferencing Services, Inc. herein "Vendor."

IN CONSIDERATION of the parties performance of the respective obligations contained herein, the parties agree as follows:

1. **Contract Documents** - This agreement shall consist of this Purchase Agreement for Video Conferencing Equipment and Maintenance, in compliance with all bid specifications and any addendum issued for the State of Missouri Contract C204013001. All such documents shall constitute the contract documents which are incorporated herein by reference. Ditch-checks for water quality

<u>Problem Identification:</u> The Boone County Public Works Department maintains more than 800 miles of road. Ditches to convey stormwater runoff are either constructed with the road or may form through erosion in areas alongside the road. In several trouble spots in the County, where the slope is greater than 6%, water runs alongside the road increasing in velocity and picking up pollutants, often undercutting or washing out gravel roads. In these places, the water moves soil, gravel and organic material into the stream with each rainfall event. When the water reaches a stream segment, there is often a slope change, resulting in a reduced velocity and the imported material is deposited. The gravel and soil particles cover spawning areas, increase turbidity and sedimentation, reduces habitat for macro invertebrates, and provides additional carbon sources to the stream.

One effective best management practice (BMP) to reduce water velocities in channelized flow is by using ditch checks. This practice reduces the stormwater velocity by ponding water in a series of small rock dams. This reduces active channel erosion and encourages sediment to drop out of solution. Currently, this effective, economical practice is not being utilized by Boone County Public Works.

<u>Anticipated Outcomes:</u> The short term goal of this project is to increase the awareness and knowledge on the proper construction, maintenance, placement, effectiveness, cost and environmental benefits of this erosion control BMP. This will be accomplished by hosting a demonstration workshop for Boone County Public Works employees, with a target of 25 participants, and a public field day (held in conjunction with other field days, such as Jefferson Farms, Hinkson or Raingarden events). The intermediate goal is to increase the use of this BMP on three sites within Boone County before the end of the minigrant project period. This will be accomplished by providing incentives to OM staff for locating potential sites and for proper post-construction maintenance. The long range goal is to improve environmental conditions by reducing NPS pollution in the form of erosion and stream sedimentation through BMP implementation.

<u>Project overview:</u> One of several problem sites will be evaluated by the project manager and engineer to establish suitability for BMP placement and demonstration site access. Once a suitable site is determined, landowners will be contacted for permission to use their property for the workshop and field day events. (The BMP will be placed in the right-of-way, not on private property). The engineer will design and oversee BMP construction. All work will be done by public works staff with county equipment. A workshop will be held to inform and educate public works staff on proper installation and BMP maintenance requirements. A public event field day will be held to demonstrate BMP effectiveness. During that event, presentations, fliers or handouts will validate cost effectiveness of the practice. It is anticipated that this BMP will be placed on an additional 3 sites by the end of the project.

<u>Target audience:</u> The County is divided into three sections and 8 grading districts. There are approximately 46 operation maintenance (OM) staff members. Staff often work early
