TERM OF COMMISSION: October Session of the August Adjourned Term

Presiding Commissioner Stamper called the meeting to order at 9:30am.

Subject: Governor Mel Carnahan

Commissioner Stamper expressed for the public record the County Commission's sorrow at the passing of Governor Mel Carnahan. He stated that Governor Carnahan's plane crashed last evening around 7:30pm. The Governor, his son Randy, and campaign aide Chris Sifford were all on board. There were no survivors.

Commissioner Stamper stated that he would like to extend condolences to the family, the citizens of the entire State of Missouri and Boone County at the loss of Governor Mel Carnahan. He stated that all flags were presently at half-staff and would remain so until the day following Governor Carnahan's funeral.

Subject: Public Hearing on Budget Amendment for the Community Shock Program

Commissioner Stamper stated that this budget amendment was read into the public record on October 5, 2000. He stated that the budget amendment was being returning to the public agenda following the required, ten-day waiting period for public comment.

Commissioner Stamper convened a public hearing on the budget amendment.

has committed to hiring Mr. Mink at an amount of \$82,000 which is above the base of the range plus other fringe benefits.

And further authorizes the hiring of David Mink at an annual salary of \$82,000, which is above the base of the range in addition to the fringe benefits outlined in the contract.

Subject: Budget Revision for Fuel

He stated that therefore additional funds would have to be added to the Public Works fuel account to cover fuel costs.

Commissioner Stamper moved to authorize a budget revision as follows:

He stated that he was not certain of whether the current difficulties were related to that event or not.

Subject: Building Code Enforcement Cooperative Agreement

Commissioner Vogt moved to approve a Building Code Enforcement Cooperative Agreement between the city of Hallsville and Boone County and authorize the Presiding Commissioner to sign the documents.

Commissioner Miller seconded the motion.

Discussion: John Patton stated that this agreement would update the County's current arrangement with the city of Hallsville for inspection services. He stated that the city of Hallsville was unable to locate a fully-signed copy of the original agreement between the County and Hallsville.

Subject: Authorize a Closed Session pursuant to Section 610.021 (1,2) RSMo.

Commissioner Miller moved to authorize a closed session on October 19, 2000 at 1:30pm in the Government Center Commission Chambers at 801 E Walnut, Columbia, Missouri, as authorized by Section 610.021 (1) RSMo. to discuss legal actions, causes of action or litigation involving a public governmental body and any confidential or privileged communications between a public governmental body or its representatives and its attorneys; and as authorized by Section 610.021 (2) RSMo. to discuss leasing, purchase or sale of real estate by a public governmental body where public knowledge of the transaction might adversely affect the legal consideration therefore.

Commissioner Vogt seconded the motion.

Commissioner Reports

Commissioner Stamper

Commissioner Stamper requested that the County Commission hold a 1-1/2 hr work session within the next ten days in order to discuss a variety of issues.

Commissioner Stamper stated that two major, fir-type trees on the Allen property (on St Charles Rd) died. He stated that the trees were outside of the County's right of way and beyond the range of what the County normally pays for. He stated that it is clear however that the project's destruction of the root system is what destroyed the trees. He stated that Boone Electric has offered to take the trees down to their stump. He stated that he would like to offer the Allens \$500 on behalf of the County in compensation for the loss of the trees.

Commissioner Vogt stated that she did not have a major concern about the \$500 offer. She stated that she understands the fact that the public has concerns about the destruction of their property.

Commissioner Miller stated that this would set a precedent. She stated that the County should determine the policy for things such as this.

Commissioner Stamper stated that he felt these kinds of matters could be handled on a case-by-case basis.

Commissioner Stamper stated if he had the consensus of the Commission, he would proceed with an offer to the Allens on this matter.

Commissioner Vogt

Commissioner Vogt stated that Farm Bureau requested that the County review Mt Hope Rd. She stated that Mr. Cunningham stated that the County is paving the road up to his fence.

Commissioner Stamper stated that it was his recollection that Mt Hope Rd was a pave-in-place project, so therefore there should not have been any major structural changes. He stated however that he would have someone review the road.

Commissioner Vogt also noted that the retirement party for Beckie Jackson, Director of Purchasing would be tomorrow from 3pm-4pm.
