Last Tuesday she received the escrow agreement and software verification which was due in November 2005. This was to take place before the company could take orders. We received a check today from the State of Missouri. They increased their payment to cover the agreement out of HAVA funds which will reduce our budget amendment to \$103,826.00.

Ms. Noren when on to thank the Commissioners, especially Commissioner Miller for allowing her to work through the process.

One "no bid" response indicated the product bid was territorial in certain areas of Missouri. Therefore, Purchasing and the Circuit Clerk's Office recommend award to the only bidder, EBE.

Total cost of the contract is \$7,879.00 to be paid out of Department 1221 – Circuit Clerk, Account Number 92000 – Replacement Office Equipment. The budgeted amount for this purchase is \$8,000.00.

## 5. Exterior Painting N. Facility 36-31MAY07

Total cost of contract is \$8,295.39 to be paid out of department 6100 – Facilities and Grounds maintenance, account number 60100 – Building Repairs/Maintenance. The original budget was \$15,000.00
