# 5. 87-05OCT07 – Telecommunications Equipment & Installation for the Non-Motorized Outreach Project (first and second reading)

# 11. Amendment to Memorandum of Understanding with Laborers' Local Union 773 (first reading)

Commissioner Pearson stated this is an amendment to the existing Memorandum of Understanding. One part amends the overtime accrual basis. If an employee has worked overtime during a particular week, he/she has an 8-hour sick period in which they can substitute 8 hours of regular time instead of sick time. The other part amends the accrual of compensatory time. This allows an employee to accrue compensatory time that can be used throughout the year subject to the leave approval policy, and caps it at 60 hours and provides for payment of any unused compensatory time at the end of the year.

### 12. Purchase Requisition for Modem (first reading)
