1. 11-05Mar10 Clinical Testing Services (first reading)

Circuit Court

Kathy Lloyd the Court Administrator was present on behalf of this item.

3. Reclassification of the Mental Health Court Administrator/ DWI Court Administrator (first reading)

Ms. Lloyd stated she believes that this should be listed as a budget revision. Ms. Lloyd stated the budget revision is in the amount of \$7,154.00. Ms. Lloyd stated we are asking to move money from class 7 in Prop L that is the line that is used to pay for treatment for mental health court participants. This year there was \$42,000.00 budgeted and when this budget was reviewed at the end of the first quarter the amount spent was only about \$4,100.00. Ms. Lloyd stated this is why we feel there are adequate funds to make this budget revision without having to come and request additional funds. Ms. Lloyd stated she has provided some history at the work session but for the benefit of Commissioner Miller, there have been some changes in personnel in the Alternative Sentencing Court. There has also been the Reintegration Court Coordinator who is also the DWI Court Administrator. This position has been funded for three years through OSCA grant funding. Ms. Lloyd stated she anticipates this funding will end in June. As a result, we have offered and our Reintegration Court Coordinator has accepted a position in our Juvenile Office and the DWI section was left without a coordinator. Ms. Lloyd stated our intent was to reclassify the Mental Health Court Coordinator position to become both a mental health/ DWI administrator. That position was classified at a lower level than the two other administrators because of the work loads required. Ms. Lloyd stated now, the combination of these two administrative positions, we believe the case loads will be equivalent to the other two and that is why we are seeking to reclassify it.

Commissioner Miller stated she believes the reclassification should go through the formal process and get it reclassified. This is so the Auditor will reclassify the position.

Ms. Lloyd stated they have spoken to the Auditor.

Commissioner Miller stated so when you do the second reading of the revision there should also be an order reclassifying the position.

Ms. Lloyd stated she had spoken to the Auditor so she is not sure what more she will need to get from her.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.
