2. Recommendations from the Job Classification Committee (first reading)

Director of Human Resources Betty Dickneite was present on behalf of this item. Ms. Dickneite stated the Job Classification Committee met earlier this week to look at two classification issues. Ms. Dickneite stated one of them was at Public Works and the other was in the Auditor's Office. Ms. Dickneite stated the committee unanimously decided to recommend we establish a new position classification titled Assistant Manager of Road Maintenance Operations on pay range 46. Ms. Dickneite stated the new class code number will be 3029, with exempt status. Ms. Dickneite stated the second request was from the Auditor's Office, and due to an upcoming vacancy, they would like to upgrade their part time Office Specialist position #331 on pay range 20 to an Account Specialist on pay range 21. Ms. Dickneite stated the Job Classification Committee members that were present were: Wendy Noren, June Pitchford, Dan Atwill and Betty Dickneite; Dwayne Carey was absent. Ms. Dickneite stated Ms. Pitchford would like to start recruitment for the Account Specialist position, and asked for a first and second reading. Ms. Dickneite stated she would like the training to start in July so the incumbent can assist.

Commissioner Miller stated she knows that's what he wants. Commissioner Miller stated she thinks the legislature will override the veto, because it had overwhelming support.

Commissioner Elkin stated he hopes they do.
