6. First reading; Debt Management Policy

Treasurer Galloway spoke to this item and said that this is a draft of the Boone County Debt Management Policy. The purpose is to provide a framework for issuing and managing debt. Rating agencies, bond buyers and citizens all recognize the importance of having a structured financial framework and a policy to issue debt. It is the responsible thing to do. Ms Galloway also said that Boone County is the first county to have such a policy and that it is recommended by the GFOA as part of responsible financial management. Key highlights on the policy include types of debt and debt structures. The policy will be posted on the Treasurer Web site to share with other counties.

Commissioner Elkin asked about credit ratings and if Boone County would ever have the opportunity to move up in its credit rating which currently is AA2. Ms Galloway stated that the County rating is specific to debt issuance and the County does not issue enough debt or the size of debt. The county had a rating in 2010 and again this year and maintained the AA2 rating.
