20. Commissioner Reports

Commissioner Atwill reported out on the recent opportunity to see, learn and understand the Emergency Management process. It is a topic of great interest because of the exposure of 911 and the possible tax for the Joint Communications. The County offices were closed on Thursday as were many other facilities in the city. Public Works was ready for the snow and did an outstanding job over the several days on the storm.

Commissioner Atwill noted how fortunate the County was to have Chief Olsen of the Boone County Fire Protection District managing the emergency services. He established a committee of people who are department heads and managers for the different agencies, staying in constant contact through conference calls and allowing each activity to request assistance when needed.

There were approximately 13,000 customers without electrical service and Boone Electric was very cooperative in helping identify what additional needs were required working with Boone County Public Works to remove trees and limbs that had fallen on lines causing a disruption in service.

A shelter was set up for those without power who needed to be kept over night. Broadway Christian Church was used by the Red Cross for this. It was a great effort to provide assistance to the public and fortunately it was not needed as badly as anticipated, but was a great exercise in bringing together all the elements when there is an emergency.

Commissioner Atwill also said he was very proud to watch this in motion and very impressed at the level of expertise that Scott Olsen brought to the effort.

The press was satisfied because of a system that was set up to provide information to the public through regular press releases produced out of Scott's office.

Although things went well above expectation, one of the negative elements was the parking in the streets where a snow plow could not adequately plow the street. There were only a few complaints, mostly from people overly eager in their expectations for snow removal and by those whose driveways were blocked once the street was plowed. It was a learning curve for all. It was a great experience and we have learned a lot.
