The meeting was called to order at 9:31 a.m.

#### Department of Public Health

1.  $1^{st}$  &  $2^{nd}$  reading; Abatement of a property located at 8350 E. Highway OO, parcel # 07-604-24-01-004.00 01

Kala Gunier from the Health Department said that the complaint originated from the Sheriff's Department. An elderly man, Mr. Macy, lives in the house. He has some health problems and is disabled. The inside of the house is worse than the outside but we have no say on how the inside of the house looks. The Health Department has dealt with this property before. We had an abatement hearing about 2 or 3 years ago with a cost of over \$1,000.

Ms. Gunier said she spoke with Mr. Macy twice yesterday and he asked for more time to clean up the property. There is and has been a lot of snow on the ground and traditionally we have tried to work with the property owner to resolve any issues. Mr. Macy has asked for an additional one month. We will not stop the proceedings and will work with him.

Commissioner Miller stated that the Commission will approve the order and the Health

Department will assume the authority to work with the property owner. The order will not be

executed unless it is necessary.

The evaluation committee recommends award for the Prosecuting Attorney's office to LexisNexis, a division of Reed Elsevier Inc. and award for Legal to West Publishing Corporation. The contracts with LexisNexis for the Prosecuting Attorney have already been approved, Commission Order 96-2013.

Cost of contract for Legal is \$667.00 per month, April 1, 2013 – December 31, 2013 (\$6,003.00) and will be paid from department 1126 – County Counselor Office, account 22500 Subscriptions / Publications. \$6,627 was budgeted.

7. Second reading; Budget Amendment – Budget revenue and expenditures for grant reimbursement of part of voting equipment maintenance agreement (1<sup>st</sup> reading 3-14-13)

County Clerk Wendy Noren said that they have received State and Federal grants each year since 2005 with this type of grant used for maintenance and security of our voting equipment. This particular Budget Amendment will be used to pay part of the maintenance of our equipment. This will be split, from general revenue - part billed out of the general elections this year and part from Federal grants.

Ms. Noren said that the amount of the grants has gone done each year. Initially started out with \$60K, then down to \$50K the next year and \$28K last year and \$21K this year. Secretary of State Carnahan has been far more generous with the money than other states have been. Last year we received over \$185K in State and Federal funds to cover things such as canvassing, voter ID cards, a GIS intern, a temp to help on petitioning, equipment maintenance, training poll workers, purchasing e-poll books and replacing parts in some of the voting equipment.

### 9. 1st & 2nd reading; 2007 Property Tax Abatement

Collector Pat Lensmeyer addressed this item. Statutorily, the County is allowed to remove uncollected taxes from the tax roll. We do this in a public setting so it can be part of the record. The taxes are stricken from the record for three reasons; Collector cannot locate the owner, bankruptcy or probate proceeding have intervened making the balances due uncollectible and property was not subject to taxation after being acquired by a tax exempt owner after January 1 of the taxable year.

Ms. Lensmeyer also said that for the tax year ending on Feb. 28<sup>th</sup>, taxes collected amounted to \$163 million and we are removing \$123 thousand. Putting this in perspective, the amount removed from the tax rolls is a small amount. In addition, if someone comes forward and offers to pay the taxes, we put the taxes back on the active tax roll.

There were no comments or questions.

Commissioner Thompson moved on this day the County Commission of the County of Boone, pursuant to Chapter 139 RSMo, does hereby authorize the Boone County Collector, Patricia S. # 10. First reading; Budget Revision to replace existing 17" monitor with a 27" LED Widescreen Business monitor

Resource Management Director Stan Shawver said that the Budget Revision is a reallocation of money originally for computer software to be used for the purchase of a 27" monitor for one of the Engineers in the department. The larger monitor will alleviate the eye strain currently experienced by the Engineer using the smaller monitor. There currently is a 27" monitor in use by one of the other Engineers and the larger monitor does help out on the eye strain. This is a worthwhile expense.

All Commissions agreed that the larger monitors do make it easier to view.

11. Second reading; First Amendment of a Cooperative Agreement with the Missouri Highways and Transportation Commission regarding the Rt. Z road improvement project (1<sup>st</sup> reading 3-21-13)

Stan Shawver said that this item is about the engineering design and relocation of the water line on the Whitehead property. As mentioned previously, the inability of MODOT and the Water District to come to a contractual agreement prompted the County to use its current contractual obligations with the Water District to allow the project to continue.

Commissioner Atwill asked when this project will be started.

Mr. Shawver indicated he did not know. He said that Ameren is relocating the gas line and the Water District is trying to get several easements approved before beginning. The construction bid has been awarded and there are indications they may start as early as this Monday on the overpass section. The roundabout will be the last thing done.

Commissioner Atwill asked Mr. Shawver to describe the possible disruptions that may occur when this starts on Monday.

Mr. Shawver said the plan is to close the interchange on Tuesday and Wednesday night while the construction crew drops the overpass to the bridge. The detour signs will be up in advance and the property owners and businesses will be contacted this week.

There were no further comments or questions.
