The meeting was called to order at 1:30 p.m.

Sheriff's Department

1. First reading; K-9 Maintenance Training Agreement between Boone County and Boonville

Captain German said this is a continuation of when Deputy Smith went through the K-9 training program and worked on a certificate with the Missouri Police K-9 Association as well as the North American Police Working Dogs Association trainer certifications.

The Department would like to start doing some maintenance training and Boonville is one of the first agencies to have us provide the continuing maintenance training for their canine. There are 20 sessions a year at \$90 per session or \$1800 for the year. The hope is by adding another agency or two, the program can continue without out of pocket expenses and make it a self-sustaining program.

There were no comments or questions.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

2. 1st & 2nd reading; 2013/2014 State Cyber Crimes Grant application

Captain German said this program started in 2007 and this year with State and Federal budget issues and funding getting held up, it has prompted the short turn around time reflected in the Aug. 7 electronic filing deadline. The timing is retro-active and we can go back and get reimbursed for expenses incurred so far. This will pay the salaries of two cyber crimes personnel and the overtime for three of the officers.

Commissioner Atwill congratulated Captain German for a job well done in securing the \$95,000 grant for this program.

3. First reading; Budget Revision for replacement printer

4. First reading; Budget Amendment Domestic Relations Resolution Fund – A Safe Way Grant

Kathy Lloyd said this is for the Family First Supervised Visitation program. The funding is from the Domestic Relations Resolution Fund (DRRF) and we have been getting this for several years now. Every year there is a Domestic Relations Resolution Fund RFP and we ask for funding from the state for this program and this year we were awarded \$10,000 beginning on July 1 based on the state fiscal year.

The Budget Amendment is for \$5,000 to put in the 2013 budget to pay for visitation services for children who need supervised visits with parents. The visits are with a licensed therapist who conducts counseling for them. This also provides assurances to the custodial parents that the child is in a safe environment for the training. It is very beneficial to both the child and parents and through these sessions the parents learn new parenting skills.

Commissioner Atwill asked where the supervised visitations take place.

Ms. Lloyd said that Boys & Girls Town has a facility and we contract a licensed therapist to conduct them at this facility.

There were no further comments or questions.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

5. First reading; Extension of Security Agreement and Cash Deposit for Meyer Industrial Drive Extension

Nicki Fuenmeler said she is requesting approval of an extension of the cash deposit and stormwater security agreement between Boone County and Robert M. Lemone Marital Trust for the Meyer Industrial Drive extension in the amount of \$38,235. The project is almost done. Some seeding needs to be done this fall with any re-seeding to take place in the spring.
