2. 1st & 2nd reading; 2013 Tax Sale Surplus Report

Chief Deputy Collector Cheri Sapp said that she is here on behalf of County Collector Pat Lensmeyer to enter into record the 2013 Tax Sale Surplus Report. The amount for this year is \$66,344.70 and is to be turned over to the County Treasurer upon Commission approval.

Commissioner Miller asked how many parcels were initially identified when this process began and what the final number of parcels was once the process was ended.

Ms. Sapp said they had started out with 354 and ended up with 13.

Commissioner Miller said that was yeoman's work to go from 354 to 13.

Commissioner Thompson said that this is very different from what we hear occurs in other counties.

Commissioner Miller said she recently visited a county where they had over 500 parcels.

Ms. Sapp said they work very hard from April to August to reduce the number.

Commissioner Atwill asked what strategy they employ to get the people to pay.

Ms. Sapp said that they do a title search and notify anyone that shows up on the report. We will notify lien holders, interested parties as well as heirs. We will actually do research to find heirs that may not be listed on the report. Notices are sent out to everyone before the sale to give them an opportunity to pay.

Commissioner Miller said it is incredible work that is done by the Collector and her staff to

get the numbers down and people to pay.
