Commissioner Atwill said he has no problem with contacting the elected officials but would like to see a better way of getting the consensus from the elected officials.

Commissioner Miller noted that when the towers went down, everybody was at work and an emergency meeting was convened to discuss our plan and how to deal with any additional security measures if needed. The problem is after hours.

Commissioner Thompson said that after her conversation with Kathy Lloyd about closing, getting everyone together was a challenge. Most people were gone or not looking at their email.

Kathy Lloyd said that they have a text service and she would look at the possibility of having Commission piggy-back onto this.

Commissioner Miller said that developing a process can be discussed in the next elected officials meeting and that the texting service is a good idea.
