## 5. First reading; Budget Amendment to cover the RMS/JMS site visit.

Jason Gibson said that this budget amendment is to increase funding for a site visit by the Boone County Sheriff's Department to another Sheriff's Department in Mississippi that is currently using Records Management software developed by the Missouri Sheriff's Association. This was not originally included in the budget because the department was unsure, during budget development, if they would go forward with this Records Management System.

Commissioner Miller asked if this is expected to come out of the 911 tax.

Mr. Gibson said that has not yet been determined. There still is uncertainty that this is a

product the Sheriff's Department would use and how it would be appropriated.

Commissioner Miller said that it is a value to see it in action wherever it is being utilized.

Commissioner Atwill asked if this was developed in Missouri, why go to Mississippi.

Mr. Gibson said this is the closest agency that is currently using this software.

Commissioner Atwill questioned why it is not being used in Missouri if it was developed here.

Commissioner Miller said there is 10 days to get additional answers before the second reading.

There were no further comments or questions.

Commissioner Atwill said that a second reading will occur after the mandatory 10 day waiting period for Budget Amendments.

6. Proclamation recognizing Public Works, GIS and Resource Management for earning 2013 Excellence in Operations Management Award

Whereas, GIS utilizes the information shared by Public Works and Resource Management to develop mapping applications, providing the ability to identify precise locations of assets and work areas;

Whereas, Boone County Public Works, GIS and Resource Management utilize the information flow between their departments to streamline the process of maintaining and improving the assets of Boone County by communicating more efficiently, developing realistic work plans for future projects, identifying cost savings, creating accurate detailed budgets and reporting financial asset changes to federal governmental accounting standards;

Whereas, as a direct result of this collaboration, Boone County Public Works, GIS and Resource Management earned the 2013 Excellence in Operations Management Award from Cartegraph;

Therefore, in recognition of the motivation and determination of Boone County Public Works, Resource Management and GIS to be leaders in the industry and provide exemplary service to Boone County citizens and visitors, the Boone County Commission extends its sincerest appreciation and congratulations.

## 11. 1st & 2nd reading; 2008 Property Tax Abatement

Pat Lensmeyer said that this identifies the amounts being removed from the active tax roll and that there are also figures that contain amounts added back on to the roll that had been

previously removed because we were able to get an opportunity to collect the taxes. The amount added back is \$5,471 and the amount removed is a little over \$155,000 out of a total of about \$167 million collected.

Commissioner Atwill asked how this compares to past years.

Ms. Lensmeyer said that it fluctuates from year to year. Bills are collected in 2013 for all previous years. We have not really looked at doing a comparison because of the fluctuations. We have increased our initiative to collect delinquent personal property taxes because of the new judicial process we are now following. We have no control over tax exempt property or bankruptcy that come off the tax rolls. We keep five years active on the tax file. Statutorily, there are two timeframes for keeping tax files. One is for three years and one is for five years. There are a lot of Collector's that just maintain three years on the active file and they have no mechanism to put anything back on. Once it is removed, it is gone and written off. Here in Boone County, we keep five years and even if the file has been removed, if there is an opportunity to collect, we will.

There were no further comments or questions.

Commissioner Atwill moved on this day the County commission of the County of Boone, pursuant to Chapter 139 RSMo, does hereby authorize the Boone County Collector, Patricia S. Lensmeyer, for the 2008 tax bill year, to strike from the delinquent tax rolls property tax balances on real estate, personal property and utility bills as follows:

These 2008 real estate, personal property and utility taxes are stricken for the following reasons:

- After due diligence, the collector cannot locate the owners; or
- Bankruptcy or probate proceedings have intervened making the balances due uncollectible;
   or,
- The real estate property was not subject to taxation after being acquired by a tax exempt owner after January 1 of the taxable year.

The above total of \$155,805.84 breaks out as follows:

## 12. First reading; Budget Amendment – City of Ashland reallocation for the Angel Lane Project

Stan Shawver said this pertains to the re-surfacing of Angel Lane. We have finalized the agreement with the City of Ashland on the specific responsibilities for the project. Boone County will administer the contract, design and pay our commitment of \$100,000 and then finance Ashland's share out of their sales tax proceeds. We will cover 30% of the base bid.

Commissioner Miller said this will be Ashland's money that we will be holding. They have an additional \$100,000 for the project that they will send to us for a total of \$200,000 before the bids are finalized. Once finalized, we will fund the project.

Commissioner Atwill asked what the cost is to the County.

Commissioner Miller said it will be 30% of the base bid.

Mr. Shawver said this is one of the more complicated deals involving the county. There are other components than just the re-surfacing. There are elements involving different types of concrete.

Commissioner Miller said this is like the Gibbs Road project, a full depth reclamation.

Mr. Shawver said that Ashland asked, because their Industrial Park fronts Angel Lane, if it would be better to beef up the area with concrete support.

Commissioner Miller said that it will be Ashland's choice on the bid award. We will get an order from the Ashland City Council on what they eventually accept. We had meetings with the Auditor's Office, Resource Management, Public Works and County Counsel to work out all the details of this agreement.

There were no further comments or questions.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

## 13. First reading; Consultant Services Agreement for the SWPPP at CEMO

Stan Shawver said that this is an agreement with A Civil Group to provide a Stormwater Pollution Prevention Plan for the Central Missouri Events Center. This is a result of a complaint received from the DNR that fill was taking place without protective measures. Bear Creek runs through the events center and in order to mitigate that we needed to design a Stormwater Pollution Prevention Plan for inspections. We will have this designed by an engineering firm, A Civil Group, and monitor as needed.

Commissioner Thompson said that the fences were not maintained properly and not extended to contain the dirt. It is now in place and looks good.

There were no further comments or questions.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

Commissioner Miller said that the TIF comes out of every sales tax and because there was a change in the final numbers of the sales tax collected for Public Works, there was a need to increase the amount of the TIF payment.

Commissioner Atwill inquired as to who gets the check.

Commissioner Miller said the city would receive the check and she has asked the Auditor's Office to prepare year end reports so this information can be clearly ascertained.
