Purchasing

1. First reading; Utilization of Jefferson City Cooperative Contract to purchase Mobile

Data Terminals and Multi Drives

Liz Sanders read the following memo:

Purchasing and the Sheriff's Department request permission to utilize the City of Jefferson's Cooperative Invitation for Bid #2718 for Mobile Data Terminals, with Turn-Key Mobile, Inc., of Jefferson City, Missouri to purchase (15) Panasonic CF-31 2.7 GHz Mobile Data Terminals and (2) Panasonic CF-31 Multi Drives.

Total cost of contract is \$50,033.00 and will be paid from department 2901 Sheriff's Law Enforcement Sales Tax, account 92301- Replacement MDT Laptops (\$57,000 was budgeted).

Commissioner Miller asked how much the original drives cost noting that the memory of the current drives is much larger.

Ms. Sanders said she does not know but will find out that information.

3. First reading; Cooperative Contract 17/2011, Earth Moving Services – Adding secondary vendor

Liz Sanders read the following memo:

Purchasing and Resource Management request permission to utilize the City of Columbia cooperative contract 17/2011 for Earth Moving Services with Roy Richardson Excavating of Hartsburg, Missouri as a Secondary Contractor (Seth Paul Excavating, Inc being Primary Contractor). It is planned that Resource Management will use funds from Department 2140, Urban Retrofit Grant for work against this contract in the event the Primary Contractor is unavailable to perform the work. This contract is in effect through December 31, 2014 and has one additional, one-year renewal. This is a term and supply contract and may be used county wide.

4. First reading; Contract Amendment Number One – Annual Maintenance and Repair of Teletrol DDC Controls System

The attached amendment clarifies that the maintenance contract work (i.e. preventive maintenance and inspections) is not subject to prevailing wage and any repair work is subject to prevailing wage.

9. Presentation on the I-70 Technological Corridor by Joyce Schulte

Joyce Schulte said this is her idea and she would like to share it with the Commission and hopes that it comes to fruition. Geographically, the Technological corridor would span Missouri along I-70, from Kansas City to St. Louis and 30 miles on either side of I-70. The background is in seeing the technology corridors of the Commonwealth of Virginia and the state of Maryland. Jobs are plentiful, specific and growing. These technology corridors have led to specific use of geographical areas and are adding revenue to states, to corporations, schools and residents. Both of these technology corridors are adding benefits of science, medicine, technology and security to our nation on a daily basis.

Ms. Schulte said she sees Missouri as being positioned for something similar. She would not be so brash as to state the technology that Missouri should designate for the I-70 corridor, but would suggest how to decide that.

With Columbia being in the center of this corridor, it is suggested that those on the County Commission invite those on state and local government of all types to come together and make the following request of our educational institutions. That question is: What research are you doing now that, if it comes to fruition, would add benefit to humans for the next 500 years? Based on the responses, the Commission would find the focus of this endeavor.

Ms. Schulte said she believes it is a matter of setting a vision, and following through. It is in inviting your neighbors in government, in commerce, in education to see the vision and following through. It is yours to do or lose. Be bold.

Ms. Schulte said she has gathered some information from the Maryland and Virginia view.

Other states have taken the opportunities from within their own to form various corridors for

various purposes. Notably, Florida and North Carolina have been mentioned recently. New York state is in the process of identifying their purpose.

Missouri, being in the center of this nation, is uniquely positioned in several ways for this. There are roads, some of which might need to be enlarged. There is water and water routes for movement of materials. There is air travel for people and products. There is plenty of space with a stable population with many people desiring better jobs with more stability. I have included some information of other corridors for the Commission to view and learn even more.

Commissioner Atwill asked it this has been presented to REDI

Ms. Schulte said it has not.

Commissioner Miller said that there is the Animal Health Corridor already designated, going from Columbia as far as Manhattan, Kansas because of their animal research.

Ms. Schulte said that Fairfax County in Virginia is advertising here in Columbia on NPR for their Northern Virginia Technological Corridor.

Commissioner Atwill asked if any incentives are being offered by them.

Ms. Schulte said just the jobs and being in that area. I/T are the big draws there and in Maryland, it is the DNA sequencing and research.

Commissioner Thompson asked if the Pharmaceutical companies in Maryland are connected to this.

Ms. Schulte said they are as well as the I/T companies taking the blood and DNA samples for

sequencing.

Commissioner Atwill asked what these areas did to establish these corridors.

Ms. Schulte said she did not know the initial piece that they did, but her supposition is that they are looking to see what the next version of technology is to move them forward. Here in Columbia, at the Fairgrounds, an idea is to have a solar company on each building demonstrating to the public the positives regarding wind generated power.

Commissioner Miller said she is not a big fan of Wind Farms and would not want to see them at the Fairgrounds.

There were no further comments and the Commissioners thanked Ms. Schulte for coming in with her presentation.
