The meeting was called to order at 1:31 p.m.

Joint Communications

1. Proclamation Recognizing Columbia/Boone County Public Safety Joint Communications

Commissioner Atwill said that we have a ceremonial function today. There will be a proclamation recognizing the Columbia/Boone County Public Safety Joint Communications organization which will become a full part of the County operations beginning January, 2015. Commissioner Atwill introduced Joint Communications Interim Director, Joe Piper.

Mr. Piper said he is pleased to introduce Carlynn Page, Associate Director of the International Academy of Emergency Dispatch. She has come from Salt Lake City to recognize the Boone County Joint Communication/911 organization for achieving accreditation in Emergency Fire Dispatch protocol.

Carlynn Page said the accreditation centers share a common goal of improving public safety

and maximizing the efficiency of the 911 systems. On August 29, 2013, Boone County Public Safety Joint Communications became the 26th of an elite group of only 28 Emergency Fire Dispatch Accreditation Centers of excellence from all over the world providing superior upto-date public care and efficient resource utilization to achieve maximum results in emergency situations.

Ms. Page said that she was told by Brian Maydwell, Operations Manager, that Boone County had the best dispatchers and now there is an external validation to back up his assertion. Boone County Joint Communications are among the very best dispatchers in the world. As Joe Piper pointed out, the accreditation is not due to one individual but is a team effort. The County Commission, Fire Administrators and dispatchers all played a vital role and each individual was a big part in this achievement.

So, on behalf of the International Academies of Emergency Dispatch, it is my distinct honor and privilege to officially present this accreditation to Boone County Public Safety Joint Communications. I would just ask that everyone congratulate each one of the fire dispatchers who work diligently each day to make sure the citizens of your community are given the highest level of care available.

Commissioner Atwill thanked Ms. Page for coming to present this accreditation and said he is proud of our Joint Communication staff for all that they do. The County is looking forward to even greater things once the new facility is completed. It is nice to know there will be qualified staff to fill it immediately.

Commissioner Miller read the following proclamation:

Whereas, Columbia/Boone County Public Safety Joint Communications provides exemplary services to the citizens of Boone County through collaboration with 13 user agencies;

Whereas, the mission statement of Public Safety Joint Communications is, "Public Safety Joint Communications is committed to serve as the vital link between citizens and public safety agencies of our community. As the 'first' first responders, we strive to provide prompt, courteous, and professional service for all of our customers. Through our actions, we help save lives, protect property and assist the public in their time of need;

Whereas, International Academies of Emergency Dispatch is a non-profit, standard-setting organization promoting safe and effective emergency dispatch services worldwide and comprised of allied academies for fire, medical and police dispatch;

Whereas, International Academies of Emergency Dispatch Fire Accreditation is based on the organization's "20 Points of Excellence" under its Fire Priority Dispatch System;

Whereas, these "20 Points of Excellence" include the current certification of all personnel authorized to process emergency calls; consistent case evaluation that meets or exceeds the Academy's minimum performance expectations; proper description of the process of outside agencies requesting a fire response; documentation for the call center's incidence (numbers) of all Fire Priority Dispatch System codes and levels; and the agency's agreement to abide by the Academy's Code of Ethics and the standards set forth for an Accredited Center of Excellence;

Whereas, accreditation by the International Academies of Emergency Dispatch is based upon the comprehensive training and performance of the staff on hand, considering the volume of calls rather than number of staff members; therefore, considering Public Safety Joint Communication's current understaffed condition, this accreditation reflects an exceptionally high quality of service;

Whereas, an example of the excellence of Public Safety Joint Communications lies in continuously exceeding the required performance levels in Point of Excellence #9, based on an independent review of its 911 calls involving a request requiring a fire/rescue component;

Whereas, International Academies of Emergency Dispatch Fire Accreditation is rare, with Columbia/Boone County Public Safety Joint Communications being only the 26th public safety dispatch center worldwide to earn this accreditation;

Therefore, in recognition of the exemplary service and tireless dedication of Columbia/Boone County Public Service Joint Communications to the safety of Boone County residents and visitors, the Boone County Commission extends its sincerest appreciation and congratulations.
