The meeting was called to order at 1:30 p.m.

Purchasing

1. First reading; Bid Award 14-27MAR14 – TRMSS Fog Seal Pavement Preservation 2014

Amy Robbins read the following memo:

14-27MAR14 – TRMSS Fog Seal Pavement Preservation 2014 opened on March 27, 2014. One bid was received and Resource Management recommends award by low bid to Christensen Construction Co.

Cost of the contract is \$59,672.97 and will be paid from department 2041 – Pavement Preservation, account 71202 – Infrastructure Preservation/Rehabilitation. \$54,783.00 was estimated for this project.

Commissioner Atwill said it would be helpful to know where the work is being done and if

this could be part of any future requests.

Ms. Robbins said she would supply that information before a second reading and will update the memo to reflect those sites.

Commissioner Miller noted that it has been some time since this was first brought to the attention of the Commission and a listing would be helpful.

There were no further comments or questions.

2. First reading; Bid Award 11-21MAR14 - Robotic Total Station

Amy Robbins read the following memo:

The Request for Proposal for 11-21MAR14 – Robotic Total Station closed on March 21, 2014. Five proposal responses were received.

The evaluation committee recommends award to Griner and Schmitz, Inc. for the purchase of a Topcon DS Series Compact Auto-Tracking Total Station in the amount of

\$17,245.00 as well as a 1-Year Extended Warranty in the amount of \$2,100.00 per their attached Evaluation Report.

Total contract amount is \$19,345.00 and will be paid from Department 2045 – RM-Design & Construction, Account 92300 – Replacement Machines & Equipment.

Commissioner Atwill asked in what way does this help the County.

Ms. Robbins said that it is a surveying device where they take the surveying data collector and set it on this station. An assistant is not longer needed. It can be positioned in the field by one person who can then just walk away.

4. First reading; Bid Award 17-28MAR14 – Lawn Care Maintenance & Seasonal Grounds Services Term and Supply

Amy Robbins read the following memo:

17-28MAR14 – Lawn Care Maintenance & Seasonal grounds Services Term and Supply opened on March 22, 2013. Five bids were received and Purchasing recommends award by low bid to Truescape, LLC of Fulton, MO.

This is a term and supply contract and invoices will be paid from departments 2040 – Public Works, 1256 – Sheriff, and 6100-Facilities Maintenance, account 60400 – Grounds Maintenance and department 2045 – Resource Management, account 71100 – Outside Services.

Commissioner Miller said she is surprised that Union Cemetery would need seven mowings.

Ms. Robbins said that the tabulations are not what are exactly budgeted. When they were asked how many mowing are needed, they said monthly to bi-weekly. So the number is somewhere between seven and fifteen and when doing the tabulations, a number was required and we chose seven. Each department will set up their schedule at the beginning of

the contract.

Commissioner Atwill asked who monitors the schedule.

Ms. Robbins said it is done by each responsible department. For this contract, those departments are Public Works, Sheriff and Resource Management.

5. First reading; Bid Award 12-27MAR14 – 2014 Preservation Chip Seal

Amy Robbins read the following memo:

12-27MAR14 – 2014 Preservation Chip Seal opened on March 27, 2014. Two bids were received and Resource Management recommends award to Missouri Petroleum Products Company, LLC for providing the lowest bid which met all required specifications. The true low bidder was found non-responsive as they did not submit the MO-DOT approved mix-design report with their bid response as requested via Addendum #2 to this bid.

Cost of the contract is \$726,781.92 and will be paid from department 2041 – Pavement Preservation, account 71202 – Infrastructure Preservation/Rehabilitation. \$712,596.00 was estimated for this project.

Commissioner Atwill asked where the money will be spent.

Commissioner Miller said it is designated for areas all over the county.

Commissioner Atwill asked for an attachment of those areas with the second reading.

Ms. Robbins said she will do that.
