Whereas, Boone County is regularly host to tourists, many of whom are attracted to the efforts in place to encourage local production and consumption, which supports the economic health of the community; and

Whereas, Boone County supports many organizations and agencies devoted to health promotion for a healthy community, recognizing the importance of local food producers, farmers' markets and education programs in promoting healthy food consumption; businesses and schools using local food products; supplemental feeding programs; and shelters that not only combat hunger but also promote consumption of local, healthy food products, all of which continue to hold tremendous potential for insuring the future health of citizens.

Prosecuting Attorney

8. First reading; Request approval for temporary hire

Bonnie Adkins said that the Prosecuting Attorney's Office is requesting to hire a temporary employee to replace Brittney Wilhite while she is on maternity leave. Brittney originally requested eight weeks of family medical leave, June 30 through August 23, 2014. She was placed on bed rest on Friday, May 30th and we are uncertain of her return date. Brittney is the legal secretary for two assistant prosecuting attorneys and has a very heavy workload. It would be difficult to absorb her duties while she is gone. We are requesting 400 hours, 40 hours a week for 10 weeks, while Brittney is gone. Peter Zekert, an Intern in our office is

able to work until August 15th if necessary. There is a spreadsheet prepared by the Auditor's Office attached to the request. The Cost will be covered by savings from Position #824, Victim Assistant, which we are currently interviewing for.

13th Circuit Court

9. First reading; Approval request for the Juvenile Detention Alternatives Initiative Grant Application

Tara Eppy said that this is an annual grant that we apply for which pays for three meals for three quarterly collaborative meetings for approximately 20 people. This year, we are also asking for three meals for three DMC meetings for approximately 12 people and six meals for six staff to complete site visits.

Commissioner Miller said there is no cost to the County as this is total re-imbursement by OSCA.

10. First reading; Approval request for the OSCA – Juvenile Justice Education Regional Training Initiative Grant Application

Tara Eppy said this is the first time applying for this grant through OSCA which is 100% reimbursable. We will be bringing back the Cognitive Behavioral Intervention Training after an absence of five years. To apply for this grant, we will need to collaborate with other circuits to jointly provide training programs that one circuit would otherwise be unable to afford or sustain. The \$1,500 noted is to cover speaker fees which will center on a cognitive behavior curriculum focused on anger reduction and interventions with violent persons.

Resource Management

11. First reading; Second Amendment to the Cost Share Agreement – Construction Improvements on Route Z

Stan Shawver said this is an amendment to the original cost share agreement set up with the Missouri Highways and Transportation Commission for funding improvements for the Route Z interchange, particularly the roundabout at St. Charles and Route Z. This amendment clarifies the responsibilities for the roundabout.

Commissioner Atwill said this is a result of negotiations by Derin Campbell which ended in a very good and important result for the County. The Commission appreciates the efforts put forward by Resource Management in getting this done. This was a source of concern at the

onset with the County doing the maintenance to make sure the Highway Department kept up its efforts on this project. The end result is they will maintain the roundabout because the County does not engage in that type of work, particularly the electrical aspect. This is a great result.
