#### **Purchasing**

### 1. First reading; Equipment transfer to the University of Missouri Police Department

Dave Engle read the following memo:

The Sheriff's Department requests permission to transfer the following equipment to the University of Missouri Police Department.

Mr. Engle said that it will be obsolete as of this October and they will use it as a trade-in.

Commissioner Atwill asked what the original cost was.

Mr. Engle said the original purchase price was \$2,500.

There were no further comments or questions.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

# 2. First reading; Budget Amendment on additional costs and revenue for the 2014 Pavement Preservation Projects

Stan Shawver said this is a joint project with the City of Columbia. The County will be the contract holder and will be reimbursed by the city.

Commissioner Atwill asked if the County cost is equal to what is listed as the city cost.

Mr. Shawver said there is a City quantity and a County quantity. The County quantity is not listed but it can be calculated using the information supplied.

Commissioner Atwill asked how quantity is determined.

Mr. Shawver said quantity is based on the responsibility of the sections of the roads and the area (square yards) of those sections.

# 3. First reading; Budget Amendment to increase revenue and expenditures for the Domestic Relations Resolution Fund

Courtney Pulley said this is for the grant that we applied for with OSCA for the Domestic Relations Resolution Fund. We were awarded the grant. The original application was for \$15,000 and we were awarded \$10,000. It has been approved and signed by our presiding judge.

Commissioner Thompson asked about the shortfall of \$5,000 and where will that money come from.

Mr. Pulley said that it will have to come from co-pays from the families so we can stay within costs. We will have to monitor the finances of these families much more closely.

The grant just opened up last week and we starting working on it last Wednesday and got the paperwork over to the Deputy County Clerk yesterday for the meeting today.

#### 8. Public Comment

Monta Welch said she is here today to speak to the Commission on the Right to Farm Constitutional Amendment 1 that will be on the August 5<sup>th</sup> ballot. She is representing herself and several other organizations she is affiliated with, notably People's Visioning. She also is on the Sustainable Farms and Community Board. She is in opposition to the Constitutional Amendment. It was originally scheduled for the November election and was moved to the August 5<sup>th</sup> election which is not enough time for public discussion to educate the public on both sides of the issue.

Ms. Welch identified various Myth vs. Fact issues relating to the proposed Constitutional Amendment and said that more information can be viewed on www.VoteNoOn1.com.

Ms. Welch closed by stating that If Right to Farm passes we, as citizens, will have no recourse to make sure that industrial farms don't pollute our water, to keep multinational corporations from abusing their power, or to stop a factory farm from being built in our community or our backyard. The language of this amendment is vague and overreaching. No other industry is

afforded such overreaching, massive and unreasonable blanket protection in our Missouri Constitution. It is unsafe to compromise the safety of our food in this manner. The Right to Farm already exists in Missouri. Revised statutes in chapter 350 and 537 grant Missouri's Family Farmers the right to engage in agricultural pursuits. This constitutional amendment is not to protect independent family farmers who are good stewards of the land and animals, but is intended to protect corporations and factory farms. Ms. Welch asked the Commission to take a stand on this with these people in opposition to the amendment.

Commissioner Atwill thanked Ms. Welch for coming and speaking to the Commission on her views towards this amendment. Commissioner Atwill also said it is not the policy of the Commission to support or oppose this type of legislation.
