The meeting was called to order at 1:31 p.m.

Purchasing

1. First reading; Cooperative Contract C214038001 – Electronic Monitoring Services

Amy Robbins read the following memo:

The Boone County Court Administrator's Office requests permission to utilize the State of Missouri cooperative contract C214038001for Electronic Monitoring Services with BI Incorporated of Boulder, CO.

Invoices will be paid from departments 1210 – Circuit Court Services, 1241 – Juvenile Office, account 71600 – Equipment Leases & Meter Charges.

Ms. Robbins said that the previous contract on this was with BI, Inc. for this exact same service through the State of Missouri Cooperative but that contract expired this month. The State put out a new RFP and BI was awarded the contract. Also, in the next couple of weeks, there will be another Cooperative Contract similar to this one through U.S. Communities for

a monitoring system and that also will be with BI, Inc. This contract has additional equipment not offered in the State of Missouri contract that the County Court would like to utilize.

There were no comments or questions.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

Human Resources

2. 1st & 2nd reading; Reclassification of part-time Supervising Jail Clinical Social Worker to non-exempt

Ms. Redel-Reed said that this is a modification of a Commission Order previously passed in May of this year. The original analysis of making this supervising position exempt is justifiable, but it turns out that it is difficult, in our system, to monitor the number of hours worked to be ACA compliant. Because of this, the position will be moved to non-exempt so the internal tracking mechanism will keep us advised as to the hours worked towards approaching the limit for providing health care.

There were no comments or questions.

Commissioner Thompson moved on this day the County Commission of the County of Boone does hereby approve the recommendation by the Job Classification Committee to change the FLSA status of the Supervising Jail Clinical Social Worker position from Exempt to Non-Exempt.

Commissioner Miller seconded the motion.

3. First reading; Recommendation by the Job Classification Committee for the 911 Director's position

Ms. Redel-Reed said this also is a modification of a previous Commission Order. In August of 2013, the Commission reviewed the job description and pay range for the 911 Directors position. At that time, the Job Classification Committee recommended the position be at range 62. After some further analysis, the request was taken back to the Committee and a new recommendation was made at range 65. This was due to the additional information provided where the salary awarded to the 911 Director in Springfield was over \$94,000/year which would be out of our range 62 but within range of 65.

Commissioner Miller asked if this is an exempt or non-exempt position.

Ms. Redel-Reed said it will be an exempt position.

Commissioner Miller said that the reporting documentation will need to be revised to reflect that information before the second reading.

Ms. Redel-Reed said that the change will be made.

There were no further comments or questions.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

This has been drafted by County Counsel and is similar to those agreements already in place with the University of Missouri Police Department, Highway Patrol and the Columbia Police Department.
