# 7. First reading; Approval of the Parameters Order for Boone Hospital Center Refunding Revenue Bonds Series 2014

Nicole Galloway said several weeks ago, Jim Caldwell from Gilmore & Bell and Jeff White from Columbia Capital were here talking about the refunding bond for the hospital series 2004 bonds. After that meeting, it was decided to do a first reading to introduce the process moving forward and that is what we are doing today. There is plenty of time to sign these documents as there is about one month to actual signing. These documents are in draft form right now, so there is no urgency.

There was an RFP to banks to directly purchase the bonds. Four responses were received and the hospital board, financial advisors and myself are evaluating these responses to get the best cost, best terms and best true interest cost which is the interest rate plus any fees. Next week, on the 21<sup>st</sup>, the hospital board will formally select a bank and then on Thursday, the 24<sup>th</sup>, it will be presented to Commission.

I won't be here on the 24<sup>th</sup>, but C. J. will be here with Gilmore & Bell and Columbia Capital. At that time, the documents still do not need to be signed, only the Summary Order. On the 24<sup>th</sup>, there is a need to lock in the bank we will be doing business with. The bids received were way better than expected. The competitiveness of the RFP process was excellent. There will be strong savings associated with this.

The process going forward is that the board will make a recommendation on a bank, then the Commission will approve by signing the order which will allow the Treasurer and Presiding Commissioner to sign the bond documents at a later date. The pricing will be locked in August. A bank will be selected and at a certain date, we will be locking in the pricing at which time we will have specifics of what the pricing is and all the terms will be set defined

terms.

So, for next Thursday, we just need to know the name of the bank that is selected to proceed with the Commission Order. There will be plenty of time after the second reading to execute all the documents.

Commissioner Atwill noted that this process and subsequent actions resulting in a quick turnaround is due to the guidelines established by the Treasurers Office for matters such as this.
