1. 1st & 2nd reading; Approve Grant Application for 2015 National Crime Victims' Rights, Community Awareness Projects

Dan Knight said the 2015 National Crime Victims' Rights Community Awareness week is April 19 – 25. We are asking for approval to apply for federal grant funds to host a 5K run/walk race to be held on April 19th. The federal grant funds are available through the 2015 National Crime Victims' Rights Project. The intent of the project is to enhance general public awareness of rights and services of victims of all types of crimes.

Sixty projects will be chosen across the United States to receive reimbursements up to \$5,000 each. We are requesting \$4,775 for this project. The money will be used for T-Shirts, rubber bracelets, signage, advertising and event management. The big thing is there are no matching requirements. There will be no cost to the participants and we will do our best to partner with other local law enforcement agencies and this will replace the traditional ceremony at the courthouse.

increase the hours to seven.

Sheriff Carey also said this is preliminary, but they have been working in-house on the 2015 budget and the changes made through behavioral health going away and bringing Dr. Reddy on board will create savings of approximately \$100,000 to the County and that does not include the prescription costs that will be reduced with this arrangement. So we think this is a good trade-off by increasing the hours up to seven.

Commissioners Atwill and Thompson said that is a great investment and savings.
