### Health Department

1.  $1^{\text{st}}$  &  $2^{\text{nd}}$  reading; Abatement of a property located at 4703 W. Knox Drive, parcel # 16-420-20-03-094.00~01

Kala Wekenborg said the Health Department received a citizen complaint on the property in question. The owner does acknowledge there is a violation and wishes to have the property abated. The owner is here and can attest to why she wants the abatement. We have contacted our contractor for a bid and have not yet received one. It is the backyard that needs to be mowed.

Commissioner Atwill asked the owner if she would like to speak on this issue.

Naomi Bettin said she is the owner of the property. She has lived there for five years and has owned it for the last two years. This is the first time the over growth has been this long and not taken care of. The 12 inch stalks are poison ivy. I went out to try and take care of it and got sprayed with the poison ivy and broke out. I have tried, but the problem is beyond what I

can handle, so I did request the abatement.

Commissioner Miller asked if it would be better if she hired a contractor to mow the lawn and avoid the administrative costs and penalties.

Ms. Bettin said she was curious how this would go if she requested the abatement. She was looking at possibly having this in the form of a bill that would be added along with her personal property taxes at the end of the year which would be more manageable since resources are scarce at this time. There are also some other things going on as well. Since the storm damage, there is a fallen tree on the property next door which she owns and rents. Ms. Bettin said it is her responsibility to remove it. There is a way of exercising an overdraft fund in her account, but those funds are not available until September 14 and it is only for \$250.

Commissioner Atwill said it has been the practice of this procedure that when an abatement is issued, the owner can still work with the Health Department to get this done on their own if they so choose to do that.

Ms. Bettin said she just wanted to know her options and if the abatement was an option.

Commissioner Miller said it is an option, just a more costly one.

There were no further comments or questions.
